Fred Dallmayr is Packey J. Dee Professor of Political Theory and teaches in the departments of philosophy and political science at the University of Notre Dame. He holds doctoral degrees from both the University of Munich and Duke University. Among his recent book publications are *Between Freiburg and Frankfurt* (Massachusetts, 1991); *The Other Heidegger* (Cornell, 1993); *Beyond Orientalism* (SUNY, 1996); *Alternative Visions* (Rowman & Littlefield, 1998); *Dialogue Among Civilizations* (Palgrave Macmillan, 2002); *Hegel: Modernity and Politics* (Rowman & Littlefield, revised ed., 2002); *Peace Talks—Who Will Listen?* (Notre Dame, 2004); and *Small Wonder: Global Power and Its Discontents* (Rowman & Littlefield, 2005).

Josef Früchtl is Professor in the Philosophy of Art and Culture Research Group at the University of Amsterdam. He has published numerous articles in the area of European philosophy and is the author of three books: *Das unverschämte Ich. Eine Heldengeschichte der Moderne* (Suhrkamp, 2004); *Ästhetische Erfahrung und moralisches Urteil. Eine Rehabilitierung* (Suhrkamp, 1996); and *Mimesis. Konstellation eines Zentralbegriffs bei Adorno* (Königshausen und Neumann, 1984). He is also the co-editor of a number of collections, including *Kunst und Demokratie. Positionen zu Beginn des 21. Jahrhunderts* (Meiner, 2003).

Matthew Grist is a research fellow with the Transcendental Philosophy and Naturalism project based at the University of Essex. His research interests center on Kant's transcendental conception of mental representation and related issues in the philosophy of mind, epistemology, and metaphysics.

Ute Guzzoni is Professor Emeritus of Philosophy at the University of Freiburg. She obtained her doctorate in 1961 with a thesis on Hegel's *Science of Logic*. Her 1969 habilitation thesis is on Aristotle's ontology. Recent monographs include *Über Natur. Zu einem anderen Naturverhältnis* (Alber, 1995); *Wohnen und Wandern* (Parerga, 1999); *Nichts. Bilder und Beispiele* (Parerga, 1999); *Sieben Stücke zu Adorno* (Alber, 2003); *Hegels Denken als Vollendung der Metaphysik. Eine Vorlesung* (Alber, 2005); *Wasser. Das Meer und die Brunnen, die Flüsse und der Regen* (Parerga, 2005).

Joanna Hodge is Professor of Philosophy at Manchester Metropolitan University. She has written *Heidegger and Ethics* (Routledge, 1995) and *Time in the Name of the Other: Reading Derrida* (forthcoming). She is currently working on the genealogy of transcendental aesthetics.

Iain Macdonald is professeur agrégé in the Department of Philosophy at the Université de Montréal and adjunct professor in the Department of Philosophy at McGill University. He has published in English and French on Hegel, Adorno, and Heidegger and is currently working on a book dealing with the Adorno-Heidegger question. His research focuses on the intersection of epistemology, metaphysics, and normativity.

Nicholas Walker has translated many essays and books in the field of continental philosophy, including writings by Heidegger, Gadamer, Adorno, and Habermas. In addition to translating the correspondence between Adorno and Walter Benjamin (Polity/Harvard, 1999), he has recently completed a translation of the correspondence between Adorno and Thomas Mann, to be published by Polity Press. He has also published articles on Hegel, Hölderlin, and Wagner.

Mario Wenning is a doctoral candidate at the New School for Social Research and the University of Frankfurt am Main. He also teaches philosophy at the New School and Seton Hall University and has published articles on narrative self-invention and Heidegger and Adorno. He is currently translating a collection of essays dealing with the Plato interpretation of the Tübingen School.

Krzysztof Ziarek is Professor of Comparative Literature at the University at Buffalo. He is the author of *Inflected Language: Toward a Hermeneutics of Nearness* (SUNY, 1994); *The Historicity of Experience: Modernity, the Avant-Garde, and the Event* (Northwestern, 2001); and *The Force of Art* (Stanford, 2004). He has also published numerous essays on Coolidge, Stein, Stevens, Heidegger, Benjamin, Irigaray, and Levinas, and co-edited a collection of essays entitled *Future Crossings: Literature Between Philosophy and Cultural Studies* (Northwestern, 2000). He is also the author of two books of poetry in Polish, *Zaimejlowane z Polski* and *Sąd dostateczny*.

Lambert Zuidervaart is Professor of Philosophy at the Institute for Christian Studies and an Associate Member of the Graduate Faculty in Philosophy at the University of Toronto. His primary research interests lie in philosophy of discourse, social philosophy, and continental philosophy, with an emphasis on German philosophy from Kant through Habermas. Zuidervaart is the author of *Social Philosophy After Adorno* (Cambridge, forthcoming), *Artistic Truth: Aesthetics, Discourse, and Imaginative Disclosure* (Cambridge, 2004), and *Adorno's Aesthetic Theory: The Redemption of Illusion* (MIT, 1991). He has co-edited three books, including *The Arts, Community and Cultural Democracy* (St. Martin's, 2000) and *The Semblance of Subjectivity: Essays in Adorno's Aesthetic Theory* (MIT, 1997).
