John Aldrich is Pfizer-Pratt University Professor of Political Science at Duke University. He has authored or coauthored *Before the Convention*, *Linear Probability, Logit and Probit Models*, *Why Parties?* and a series of books on elections, the most recent of which is *Change and Continuity in the 2004 Elections*. His articles have appeared in *American Political Science Review*, *American Journal of Political Science*, *Journal of Politics*, *Public Choice*, and other journals and edited volumes.

Stephen Ansolabehere is the Elting R. Morison Professor of Political Science at the Massachusetts Institute of Technology. He studies elections, democracy, and the mass media. He is coauthor (with Shanto Iyengar) of *The Media Game* and *Going Negative: How Political Advertising Alienates and Polarizes the American Electorate*. His articles have appeared in *American Political Science Review*, *British Journal of Politics*, *Journal of Politics*, *Legislative Studies Quarterly*, *Public Opinion Quarterly*, *The Quill*, and *Chance*.

Eric Berglöf is chief economist and special advisor to the president at the European Bank for Reconstruction and Development. He is a widely published and internationally respected specialist in the field of transition economics. His focus has been on policy-related issues in transition economies, and he has frequently provided advice to national governments and international institutions, including the International Monetary Fund and the World Bank. Before his current position, he was director of the Stockholm Institute of Transition Economies (SITE) and professor at the Stockholm School of Economics from 2000 to 2005.

William Bernhard is an associate professor of political science at the University of Illinois at Urbana-Champaign. His work has appeared in *American Journal of Political Science*, *American Political Science Review*, *International Organization*, *International Studies Quarterly*, *Journal of Politics*, and the *Quarterly Journal of Political Science*. His most recent book, *Democratic Processes and Financial Markets*, examines the conditions under which political events affect the behavior of asset prices.

David W. Brady is deputy director and senior fellow at the Hoover Institution. He is also the Bowen H. and Janice Arthur McCoy Professor of Political

Science and Leadership Values in the Stanford Graduate School of Business and professor of political science in the School of Humanities and Sciences at Stanford. He is an expert on the U.S. Congress and congressional decision making and has authored *Congressional Voting in a Partisan Era* and *Critical Elections in the U.S. House of Representatives*.

Brandice Canes-Wrone is an associate professor of politics and public affairs at Princeton University. Her interests include political institutions, representation, and formal and quantitative methods. She is the author of *Who Leads Whom? Presidents, Policy, and the Public* and numerous articles in the leading journals of political science including *American Journal of Political Science*, *American Political Science Review*, and *Journal of Politics*. She is currently on the editorial boards of *American Journal of Political Science*, *American National Election Studies*, *Presidential Studies Quarterly*, and *Public Choice*.

Jamie L. Carson is an assistant professor of political science at the University of Georgia. He received his Ph.D. from Michigan State University in 2003. His research interests include congressional politics and elections, American political development, and separation of powers. He has published articles in a number of scholarly journals, including *American Journal of Political Science*, *Journal of Politics*, *Legislative Studies Quarterly*, *Political Analysis*, *Political Research Quarterly*, and *Public Choice*.

Joshua D. Clinton is an assistant professor in the Department of Politics at Princeton University. His research interests largely focus on the incentives for position-taking and lawmaking activity in the legislative and electoral arenas. A sample of published work includes "Representation in Congress: Constituents and Roll Calls in the 106th House" in *Journal of Politics*; "The Statistical Analysis of Roll Call Voting (with Simon Jackman and Doug Rivers) in *American Political Science Review*"; "Testing Accounts of Legislative Strategic Voting" (with Adam Meirowitz) in *American Journal of Politics*; and "Integrating Voting Theory and Roll Call Analysis: A Framework" (with Adam Meirowitz) in *Political Analysis*.

Gary W. Cox is Distinguished Professor of Political Science at the University of California at San Diego. In addition to numerous articles in the areas of legislative and electoral politics, he is the author of *The Efficient Secret* and *Making Votes Count* and coauthor of *Elbridge Gerry's Salamander*, *Legislative Leviathan*, and *Setting the Agenda*.

Erik J. Engstrom is an assistant professor of political science at the University of North Carolina. His research focuses on American national institutions and political development. His current projects include research on the politics of congressional redistricting during the 19th century and an examination of the impact of presidential coattails on party control of the U.S. Congress.

Charles J. Finocchiaro is an assistant professor of political science at the University of South Carolina. He received his Ph.D. from Michigan State University, where he was a fellow in the Political Institutions and Public Choice Program. His research interests include political parties and legislative organization, congressional elections, and institutional development. His published work has appeared in outlets such as *Political Research Quarterly* and *American Politics Research*.

Craig Goodman is an assistant professor of political science at Texas Tech University. He is a coauthor of "Lame Duck Legislators and Consideration of the Ship Subsidy Bill of 1922," which was published in *American Politics Research*. Currently he is working on several projects examining legislative behavior in the United States Senate and redistricting in Texas.

Chris Den Hartog is an assistant professor of political science at Cal Poly, San Luis Obispo. His research deals primarily with how the interaction between political parties and congressional institutions affects policy decisions made by Congress, in both historical and contemporary periods. Current projects include a study of the role of the majority party in the contemporary Senate and a study of the development of the modern legislative process in the 19th-century House of Representatives.

Shigeo Hirano is an assistant professor of political science and a faculty fellow at the Institute for Social and Economic Research and Policy at Columbia University. His research focuses on issues related to elections and representation in both the United States and Japan. His current projects are related to the incumbency advantage, electoral institutions, intraparty competition, and minor political parties.

Jeffrey Rogers Hummel is an assistant professor of economics and history at San Jose State University. He is the author of *Emancipating Slaves, Enslaving Free Men: A History of the American Civil War*.

Gary C. Jacobson is a professor of political science at the University of California at San Diego. He is the author of *Money in Congressional Elections*, *The Politics of Congressional Elections*, and *The Electoral Origins of Divided Government* and coauthor of *Strategy and Choice in Congressional Elections*, *American Parties in Decline*, and *The Logic of American Politics*. His latest book is *A Divider, Not a Uniter: George W. Bush and the American People*. He is a fellow of the American Academy of Arts and Sciences.

Jeffery A. Jenkins is an assistant professor of political science and a faculty fellow in the Institute for Policy Research at Northwestern University. He works in the areas of American political institutions, representation, and American political development. His work has appeared in *American Journal of Political Science*, *Journal of Politics*, *Legislative Studies Quarterly*, *Political Analysis*, *Electoral*

Studies, *Studies in American Political Development*, and *Journal of Economic History*, as well as peer-reviewed outlets. He is currently finishing a book manuscript with Charles Stewart III titled *Fighting for the Speakership: The House and the Rise of Party Government*.

Samuel Kernell is a professor of political science at the University of California at San Diego. He is the author of *Going Public: New Strategies of Presidential Leadership* and coauthor of *The Logic of American Politics, Strategy and Choice in Congressional Elections*, and *Chief of Staff: Twenty-five Years of Managing the Presidency*. He has edited or coedited three books: *The Politics of Divided Government*, *Parallel Politics: Economic Policymaking in the United States and Japan*, and *Principles and Practice of American Politics*.

D. Roderick Kiewiet is a professor of political science at the California Institute of Technology. He is the author of *Macroeconomics and Micropolitics* and coauthor of *The Logic of Delegation* and *Legislatures: Comparative Perspectives on Representative Assemblies*. He has authored or coauthored articles on several subjects, including the effects of economic conditions on voting behavior, congressional elections, legislative politics, Russian politics, ethnic politics in California, state and local government, public school finance, and American political history.

Gregory Koger is an assistant professor of political science at the University of Montana. He earned his Ph.D. from University of California at Los Angeles in 2002, and he has published articles on cosponsoring in *Legislative Studies Quarterly* and institutional change in the *Journal of Politics*. His research focuses on filibustering, institutional change, and political parties. He is currently preparing a book manuscript on the history of filibustering in the U.S. House and Senate.

John S. Lapinski is an assistant professor of political science at Yale University and a resident fellow in the Institute for Social and Policy Studies. His research concerns the Congress, political parties, elections, history, and quantitative methods. His publications have appeared in *American Journal of Political Science*, *Journal of Politics*, *Perspectives on Politics*, and *British Journal of Political Science*. He is also coeditor of *The Macropolitics of Congress*.

Mathew D. McCubbins is the Chancellor's Associates Chair VIII in the Department of Political Science at the University of California at San Diego. He is the coauthor of five books, *The Logic of Delegation*, *Legislative Leviathan*, *The Democratic Dilemma*, *Stealing the Initiative*, and *Setting the Agenda: Responsible Party Government in the U.S. House of Representatives*. He is also editor or coeditor of eight additional books and has authored more than 75 articles.

Timothy P. Nokken is an assistant professor in the Department of Political Science at Texas Tech University. He received his Ph.D. from the University of Illinois at Urbana-Champaign in 1999. His research investigates roll-call

voting behavior and the role of parties in agenda development in the U.S. Congress. His work appears in *Legislative Studies Quarterly*, *American Politics Research*, and *Journal of Theoretical Politics*.

Julia Rabinovich is a Ph.D. candidate in the Political Science Department at Northwestern University. Her interests include political behavior and the impact of public opinion on public policy. Her current research focuses on the impact of public opinion on the policy-making decisions of unelected officials, especially in the areas of regulatory policy and foreign trade policy.

Jason M. Roberts is an assistant professor at the University of Minnesota. His research interests include American politics, the U.S. Congress, elections, and Supreme Court nominations. He has published articles in *American Journal of Political Science*, *Journal of Politics*, and *Congress and the Presidency*.

David W. Rohde is a professor of political science at Duke University and director of the Political Institutions and Public Choice Program. He received his Ph.D. from the University of Rochester. He was editor of *American Journal of Political Science* and chair of the Legislative Studies Sections of the American Political Science Association. He is the author of books and articles on various aspects of American national politics (most dealing with elite behavior in institutional contexts), including a series of 13 books on national elections since 1980 coauthored with Paul Abramson and John Aldrich.

Howard Rosenthal is a professor of politics at New York University and Roger Williams Straus Professor of Social Science, Emeritus, at Princeton University. He previously served on the faculty of Carnegie Mellon University for 27 years. He is an author of *Polarized America: The Dance of Ideology and Unequal Riches*; *Congress: A Political Economic History of Roll Call Voting*; and *Partisan Politics, Divided Government, and the Economy*. He is a member of the American Academy of Arts and Sciences and has served as a fellow of the Center for Advanced Study in the Behavioral Sciences, a visiting scholar at the Russell Sage Foundation, a national fellow at the Hoover Institution, and Sherman Fairchild Distinguished Scholar at the California Institute of Technology.

Kevin A. Roust is a visiting assistant professor of political science at Duke University. His research broadly addresses institutions, with a particular focus on the effects and stability of endogenous institutions such as constitutions or parliamentary rules. His dissertation, "Minority Rights in Majoritarian Institutions," considered the role of the minority party in the U.S. House of Representatives. He received his Ph.D. from the California Institute of Technology in 2005.

Elizabeth Rybicki is an analyst in American national government at the Congressional Research Service and a Ph.D. candidate in political science at the University of Minnesota.

Brian R. Sala is an assistant professor of political science at the University of California at Davis. His research focuses on applications of positive political theory to the study of congressional behavior and has appeared in *American Political Science Review*, *American Journal of Political Science*, and *Journal of Politics*. He is currently studying the relationship between bill cosponsorship and corporate campaign contributions in the Senate.

Eric Schickler is a professor of political science at the University of California at Berkeley. He is the author of *Disjointed Pluralism: Institutional Innovation and the Development of the U.S. Congress* and coauthor of *Filibuster: Obstruction and Lawmaking in the U.S. Senate* and *Partisan Hearts and Minds*.

Wendy J. Schiller is an associate professor of political science and public policy at Brown University. She is the author of *Partners and Rivals: Representation in U.S. Senate Delegations* and coauthor of *The Contemporary Congress*. Before coming to Brown, she held fellowships at the Brookings Institution and Princeton University, and she worked as a legislative staff member to Senator Daniel P. Moynihan and Governor Mario M. Cuomo.

Steven S. Smith is the Kate M. Gregg Professor of Social Sciences and the director of the Murray Weidenbaum Center on the Economy, Government, and Public Policy at Washington University. He is the author or coauthor of *The American Congress, Committees in Congress, Call to Order: Floor Politics in the House and Senate, Managing Uncertainty in the House of Representatives: Adaptation and Innovation in Special Rules, Politics or Principle: Filibustering in the United States Senate, The Politics of Institutional Choice: The Formation of the Russian State Duma*, and two forthcoming books, *Parties in Congress: Essays on the Study of Party Influence on Legislative Outcomes* and *Steering the Senate: The Development of Party Leadership in the U.S. Senate*.

James Snyder is the Arthur and Ruth Sloan Professor of Political Science and Economics at the Massachusetts Institute of Technology. He has published over 50 articles in political science and economics, mainly on questions of legislative representation.

Charles Stewart III is professor and head of the Department of Political Science at the Massachusetts Institute of Technology. He has written extensively about congressional elections, committees, leadership, and budgeting, often from a historical perspective. His most recent books are *Analyzing Congress* and *Fighting for the Speakership*.

Michael Tofias is an assistant professor of political science at the University of Wisconsin at Milwaukee. He received his B.A. from Cornell University in 2000 and his Ph.D. from Duke University in the summer of 2006. He has previously published in *Public Choice*. While working on the study for this volume, he was supported in part by Duke's Social Science Research Institute.

Robert Parks Van Houweling is an assistant professor in the Charles and Louise Travers Department of Political Science at the University of California at Berkeley. His work has been published in *American Political Science Review* and *American Journal of Political Science*.

Craig Volden is an assistant professor at Ohio State University. He pursues research and teaching interests in American politics and quantitative and formal methods. His work explores coalition formation and the interaction among political institutions, with a specific focus on legislative-executive relations and on federalism. He is coauthor of *Revolving Gridlock: Politics and Policy from Jimmy Carter to George W. Bush* and has published numerous articles in *American Journal of Political Science*, *Journal of Politics*, *Journal of Law, Economics and Organization*, and *Publius: The Journal of Federalism*.

Gregory Wauro is an associate professor of political science at Columbia University. He is the coauthor of *Filibuster: Obstruction and Lawmaking in the U.S. Senate*.

Barry R. Weingast is a senior fellow at the Hoover Institution as well as the Ward C. Krebs Family Professor in the Department of Political Science at Stanford University. He is a fellow of the American Academy of Arts and Sciences and is coauthor of *Analytic Narratives*.

Donald R. Wolfensberger has been director of the Congress Project at the Woodrow Wilson International Center for Scholars since 1999. He initially came to the center in 1997 as a guest scholar and then a public policy scholar, during which time he wrote *Congress and the People: Deliberative Democracy on Trial*. He is a 28-year staff veteran of the U.S. House of Representatives, culminating as chief of staff of the House Rules Committee in the 104th Congress. He earned a B.A. in English from North Central College and successfully completed the course work toward an M.A. in political science at the University of Iowa.
