The Honorable Joanne F. Alper. Judge, Circuit Court for the Seventeenth Judicial Circuit, Arlington, Virginia. Judge Alper received a B.A., *magna cum laude* from Syracuse University in 1972 and a J.D., with honors, from the George Washington University Law School in 1975. She has been a trial judge in Virginia since 1991 and has been a frequent lecturer at state and national continuing education programs for both judges and lawyers. Judge Alper also serves as a member of the Board of Trustees of Syracuse University.

Keith J. Bybee. Associate Professor of Political Science and Michael O. Sawyer Chair of Constitutional Law and Politics at Syracuse University's Maxwell School of Citizenship and Public Affairs. Bybee directs the Sawyer Law and Politics Program at Maxwell and the Institute for the Study of Judiciary, Politics, and the Media at Syracuse University. He is author of *Mistaken Identity: The Supreme Court and the Politics of Minority Representation* (Princeton University Press, 1998; second printing, 2002). His current research examines the role of courtesy and hypocrisy in the judicial process, and he is in the process of completing a book manuscript entitled, *Legal Courtesy: A Study of Courts, Politics and Hypocrisy* (under contract with Stanford University Press). Before he began teaching at Maxwell in 2002, he was a faculty member in the Department of Government at Harvard University.

Charles Gardner Geyh. The John F. Kimberling Chair in Law, Indiana University at Bloomington. Geyh is the author of *When Courts and Congress Collide: The Struggle for Control of America's Judicial System* (University of Michigan Press, 2006), and coauthor of *Judicial Conduct and Ethics* (4th ed., Lexis Law, forthcoming). He has served as reporter to four American Bar Association Commissions: the Joint Commission to Evaluate the Model Code of Judicial Conduct; the Commission on the 21st Century Judiciary; the Commission on Public Financing of Judicial Campaigns; and the Commission on the Separation of Powers and Judicial Independence. He has also served as reporter to the Constitution Project Task Force on the Distinction between Intimidation and Legitimate Criticism of Judges, as director of the American Judicature Society's Center for Judicial Independence, as consultant to the Parliamentary Development Project on Judicial Independence and Administration for the Supreme Rada of Ukraine, as consultant to the Pennsylvania House of Representatives on the impeachment and removal of Pennsylvania Supreme Court Justice Rolf Larsen, as consultant to the National Commission on Judicial Discipline and Removal, and as legislative liaison to the Federal Courts Study Committee. He currently serves on the Board of Directors of Justice at Stake and on the Steering Committee of the Constitution Project's Courts Initiative.

Tom Goldstein. Former reporter, the *New York Times*, and other publications, and is director of the Mass Communications program at the University of California at Berkeley. He served as the dean of the Graduate School of Journalism at Berkeley and was dean of the school at Columbia University as well.

The Honorable James E. Graves, Jr. Justice, Supreme Court of Mississippi. Prior to joining the supreme court in 2001, Justice Graves served as a circuit court judge for ten years. He has taught trial advocacy at Harvard Law School and has been a jurist-in-residence at the Syracuse University College of Law. He has also been adjunct professor at Jackson State University, Tougaloo College, and Millsaps College where he taught media law, civil rights law, and sociology of law. In 2005, the 100 Black Men of America named him the recipient of its Equal Justice Award; and in 2006, the National Conference of Black Mayors gave him the President's Award. He received his undergraduate degree from Millsaps College, and is a graduate of Syracuse University's College of Law and Maxwell School of Citizenship and Public Affairs.

Anthony Lewis. Former *New York Times* columnist and James Madison Visiting Professor, Graduate School of Journalism, Columbia University. Lewis is author of *Gideon's Trumpet* and *Make No Law: The Sullivan Case and the First Amendment*, both published by Vintage.

Dahlia Lithwick. Senior Editor and Legal Correspondent, *Slate.com*. Lithwick's work has appeared in the *New Republic*, *Commentary*, the *New York Times*, the *Washington Post*, and the *Los Angeles Times*, among other places. She is a weekly legal commentator for the NPR show *Day to Day*, and her work appears in the *Washington Post's Outlook* section every other week. She cowrote "Me v. Everybody: Absurd Contracts for an Absurd World" (Workman, 2003), a legal humor book. She is also author of "I Will Sing Life: Voices from the Hole in the Wall Gang Camp" (Little, Brown, 1992), a book about seven children from Paul Newman's camp who have life-threatening illnesses. Lithwick has received several awards from the Online News Association and in 2005 she was voted by the readers of *Legal Affairs* magazine as one of the twenty most influential legal thinkers in America.

Mark Obbie. Visiting Assistant Professor, S.I. Newhouse School of Public Communications, Syracuse University. Obbie teaches newspaper and magazine journalism and media law, and he is developing a legal reporting program with a grant from the Carnegie Corporation of New York. He is the former executive editor of *The American Lawyer* magazine and in his twenty-five years as a legal journalist has been a reporter or editor for the *Houston Post*, *Texas Lawyer* weekly newspaper, and *Counsel Connect*, a first-generation online service for lawyers.

G. Alan Tarr. Distinguished Professor of Political Science and Director, Center for State Constitutional Studies, Rutgers University-Camden. He is the author of *Understanding State Constitutions* (Princeton University Press, 1998)

and *Judicial Processes and Judicial Policymaking* (4th ed., Wadsworth, 2006), and the coeditor of *State Constitutions for the Twenty-first Century* (3 vols. SUNY Press, 2006), *Constitutional Origins, Structure, and Change in Federal Countries* (McGill-Queen's University Press, 2005), and *Federalism, Subnational Constitutions, and Minority Rights* (Praeger Paperback, 2004).

The Honorable John M. Walker, Jr. Chief Circuit Judge on the United States Court of Appeals for the Second Circuit. Formerly, he was a district judge for the Southern District of New York, an assistant secretary of the Treasury for Enforcement and Operations, a partner at Carter, Ledyard & Milburn in New York City, where he specialized in commercial litigation, and an assistant United States attorney for the Southern District of New York in the criminal division. Judge Walker is an adjunct professor at New York University Law School, a visiting lecturer at Yale Law School, and on the teaching faculty of the Institute of Judicial Administration's Appellate Judges Seminar. He is a graduate of Yale College and the University of Michigan Law School.
