Syed Farid Alatas is head of the Department of Malay Studies and associate professor of sociology, National University of Singapore (<http://www.fas.nus.edu.sg/soc>). His areas of research and teaching include the historical sociology of Muslim societies, Muslim reform ideologies, inter-religious dialogue, and the philosophy and history of the social sciences. His recent publications include *Alternative Discourses in Asian Social Science: Responses to Eurocentrism* (2006) and "From *Jāmi' ah* to University: Multiculturalism and Christian-Muslim Dialogue," *Current Sociology* (2006).

Abbas Barzegar is a Ph.D. candidate in the Graduate Division of Religion at Emory University. In addition to work on contemporary Muslim political movements, his research focuses on Muslim historical writing in the context of Sunni-Shii polemics during the 'Abbasid period. He has also conducted extensive fieldwork on Muslim communities in the United States.

Donald K. Emmerson is professor of political science at Stanford University where he is affiliated with the Abbasi Program in Islamic Studies and directs the Southeast Asia Forum. His interests include Islam and democracy, especially in Southeast Asia. Relevant essays include "One Nation under God? History, Faith, and Identity in Indonesia" in *Religion and Religiosity in the Philippines and Indonesia* (2005) and "Presumptive Universals and the Cult of Local Knowledge" (2004).

Hillel Fradkin, Ph.D., is currently senior fellow at the Hudson Institute where he is the director of its Center on Islam, Democracy and the Future of the Muslim World. Fradkin received his degree in Islamic Studies from the University of Chicago for work done under the direction of the late Pakistani scholar and theologian Fazlur Rahman. He is co-editor with Husain Haqqani and Eric Brown of the journal *Current Trends in Islamist Ideology*. His recent publications include "The History

and Unwritten Future of Salafism” (2008) and “Recent Statements of Islamist Ideology: Bin Laden and Zarqawi Speak” (2005).

Graham E. Fuller is adjunct professor of history at Simon Fraser University in Vancouver, BC. He worked and lived overseas for seventeen years, mostly in the Middle East. He is a former vice-chair of the National Intelligence Council at the CIA, responsible for strategic forecasting. Mr. Fuller was a senior political scientist at the RAND Corporation for twelve years. He has written many books and articles relating to the Middle East, global geopolitics, democracy in the Muslim world, and Islamic politics. Among others, his books include *A Sense of Siege: The Geopolitics of Islam and the West* (1995), *The Arab Shi'a: The Forgotten Muslims* (1999), and *The Future of Political Islam* (2003).

Hassan Hanafi is professor of philosophy at Cairo University in Egypt. His many books and articles are well known for his interpretations of Islamic thought for Western scholars and his application of Continental philosophy, especially hermeneutic theory, to Muslim texts. He studied at the Sorbonne in Paris and wrote two dissertations in French, and he later studied the works of Edmund Husserl in German. Among his many works are *From Creed to Revolution* (1988, in Arabic) and *Introduction to the Study of Occidentalism* (1991, in Arabic). Dr. Hanafi has lectured and taught in the Middle East, Asia, Europe, and the United States.

Amir Hussain is associate professor in the Department of Theological Studies at Loyola Marymount University in Los Angeles. He specializes in contemporary Muslim communities in North America but is also interested in comparative religion as well as religion in popular culture. He is the author of *Oil and Water: Two Faiths, One God* (2006) and *Muslims: Islam in the West in the 21st Century* (forthcoming).

M. Zuhdi Jasser is a physician in private practice in Phoenix, Arizona, specializing in internal medicine and nuclear cardiology. He served as the president of the Arizona Medical Association (ArMA) until June 2007 and chairs the bioethics committee for Good Samaritan Regional Medical Center. He co-founded the Children of Abraham, a local Jewish-Muslim dialogue group in 2000 and is on the board of the Arizona Interfaith Movement. Dr. Jasser has also been an advisor on Islamic affairs to the U.S. Embassy in the Netherlands.

Bruce Lawrence is the Nancy and Jeffrey Marcus Humanities Professor of Religion at Duke University. He lectures on Islam widely in the United States and in the Muslim world. Among his many published articles and books are *Messages to the World: The Statements of Osama bin Ladin* (2005), *New Faiths, Old Fears: Muslims and Other Asian Immigrants in American Religious Life* (2004), *Shattering the Myth* (1998) and *Defenders of God: The Fundamentalist Revolt Against the Modern Age* (1995).

Anouar Majid is professor and founding chair of the Department of English at the University of New England in Maine. He is the author of *Unveiling Traditions: Post-colonial Islam in a Polycentric World* (2000), *Freedom and Orthodoxy: Islam and Difference in the Post-Andalusian Age* (2004), and *A Call for Heresy: Why Dissent Is Vital to Islam and America* (2009). He also published a novel titled *Si Yussuf* (2005) and edits *Tingis*, a Moroccan-American magazine he co-founded in 2003. His new book about Moors and minorities in the modern West will be published in 2009.

Richard C. Martin is professor of Islamic Studies and History of Religions at Emory University and president of the American Research Center in Egypt. He writes and lectures on Islamic religious thought; religion, social conflict, and violence; and Islam and secularism. With Mark R. Woodward and Dwi Atmaja, he is the author of *Defenders of Reason in Islam: Mu'tazilism from Medieval School to Modern Symbol* (1997). He is editor-in-chief of *The Encyclopedia of Islam and the Muslim World*.

Ziba Mir-Hosseini holds a Ph.D. in social anthropology from the University of Cambridge and lectures at the London University School of Oriental and African Studies. She is an educator, writer, and filmmaker whose research focuses particularly on feminist and development issues. Her books include *Feminism and the Islamic Republic: Dialogues with the Ulema* (1999) and, with Richard Tapper, *Islam and Democracy in Iran: Eshkevari and the Quest for Reform* (2006). With Kim Longinotto she produced the documentary films *Divorce Iranian Style* (1998) and *Runaway* (2001).

Angel Rabasa, Ph.D. is a senior political scientist at the RAND Corporation. He has written extensively about religious and political trends in the Muslim world and in Southeast Asia in particular. He was the lead author of the RAND studies *The Muslim World After 9/11, Beyond al-Qaeda (Parts 1 and 2)* (2005), and *Building Moderate Muslim Networks* (2008). He has contributed to the International Institute for Strategic Studies (IISS) Adelphi Paper series and the Hudson Institute's *Current Trends in Islamist Ideology*, among other publications.

Feisal Abdul Rauf is founder and CEO of the American Society for Muslim Advancement (ASMA Society) and Imam of Masjid Al-Farah, a mosque in lower Manhattan. Imam Feisal is also the architect of the Cordoba Initiative, an inter-religious blueprint for improving relations between the Muslim world and the West. He is the author of several works, including *What's Right with Islam: A New Vision for Muslims and the West* (2004). He appears frequently on CNN, BBC, and other international media.

Richard Tapper is professor emeritus of anthropology in the University of London. He has conducted extensive field research in Iran, Afghanistan, and Turkey. His

interests include cultural and historical aspects of pastoral nomadism; tribal and ethnic minorities and the state; ethnographic film; and anthropological approaches to Islam. His most recent books are *The New Iranian Cinema: Politics, Representation and Identity* (edited, 2002) and, with Ziba Mir-Hosseini, *Islam and Democracy in Iran: Eshkevari and the Quest for Reform* (2006).

Daniel M. Varisco is professor and chair of the Department of Anthropology at Hofstra University and former president of the Middle East Section of the American Anthropological Association. He has conducted ethnographic and historical research in Yemen, Egypt, and Qatar. He is the author of *Reading Orientalism: Said and the Unsaid* (2007) and *Islam Obscured: The Rhetoric of Anthropological Representation* (2005). He serves as editor of the online journal *CyberOrient* (www.cyberorient.net), co-editor of *Contemporary Islam*, and webshaykh of the blog *Tabsir* (www.tabsir.net).

Nadia Yassine is founder and head of the feminist branch of the Moroccan Islamist movement, *Al Adl Wa Al Ihssane* (Justice and Spirituality). She is the daughter of Cheikh Abdesslam Yassine, popular founder and spiritual leader of the organization.
