RONALD L. AKERS is a professor of criminology and sociology in the Department of Criminology, Law, and Society at the University of Florida. He is the author or coauthor of *Deviant Behavior*, *Criminological Theories*, and *Social Learning and Social Structure* as well as more than 100 book chapters and articles in sociology and criminology journals such as *Social Forces*, the *Journal of Research in Crime and Delinquency*, and *Criminology*. He is a past president of the American Society of Criminology.

He is the author of *Violence and Gender Reexamined*, coauthor of *Violence, Aggression, and Coercive Actions*, and coeditor of *Aggression and Violence*. In addition, he is the author of dozens of articles in the social science and criminological literature.

DAVID O. FRIEDRICHS is a professor of sociology and criminal justice and Distinguished University Fellow at the University of Scranton. He is the author of *Trusted Criminals: White Collar Crime in Contemporary Society* and *Law in Our Lives* and editor of *State Crime*. In addition, he has contributed more than 100 articles, book chapters, and entries in encyclopedias.

GILBERT GEIS is professor emeritus in the Department of Criminology, Law, and Society at the University of California, Irvine, and the author or coauthor of two dozen books, including *White Collar and Corporate Crime*, *Criminal Justice and Moral Issues*, and *Not the Law's Business: An Examination of Homosexuality, Abortion, Prostitution, Narcotics, and*

Gambling in the United States. Gilbert Geis is a past president of the American Society of Criminology.

ERICH GOODE is professor emeritus of sociology at the State University of New York at Stony Brook and is currently a visiting scholar at New York University. He is the editor of a half-dozen anthologies, most recently, *Extreme Deviance*, and the author of ten books, including *Drugs in American Society*, *Deviant Behavior*, *Between Politics and Reason: The Drug Legalization Debate*, and *Deviance in Everyday Life*.

MICHAEL R. GOTTFREDSON is a professor of criminology, law, and society and sociology and the executive vice-chancellor and provost at the University of California, Irvine. He has published numerous articles, chapters, and books, including *Control Theories of Crime and Delinquency*, *The Generality of Deviance*, and most notably, *A General Theory of Crime*.

DAVID F.
