ROBERT MARANTO is the 21st Century Chair in Leadership in the Department of Education Reform at the University of Arkansas in Fayetteville. Maranto's research interests include education reform, the presidency, and civil service reform. Bush: The President at Midterm* (SUNY Press, 2004) and *The Second Term of George W. Bush* (Palgrave Macmillan, 2006).

JEFFREY E. COHEN is professor of political science at Fordham University and visiting senior research scholar, Center for the Study of Democratic Politics, Woodrow Wilson School of Public and International Affairs, Princeton University (2008–2009). He is author or editor of numerous books, including *The Presidency in an Era of 24-Hour News* (Princeton University Press, 2008), *Public Opinion in State Politics*, editor (Stanford University Press, 2006), and *Presidential Responsiveness and Public Policy Making: The Public and the Policies That Presidents Make* (University of Michigan Press, 1997). The latter won the 1998 Richard E. Neustadt Award from the Presidency Research Group of the American Political Science Association.

LAURA CONLEY is a graduate of Wesleyan University with a degree in government and a certificate in international relations. She is currently a special assistant for national security and international policy at the

Center for American Progress, where she researches defense and military affairs. Prior to joining the center, she worked as a presidential campaign field organizer in Iowa. She has published in the *Baltimore Sun*, the *Boston Globe*, and *Innovations: Technology, Governance, Globalization*. Conley previously completed internships with the Center of Concern and the office of Senator Russ Feingold. She studied European politics in Copenhagen, Denmark.

JACK COVARRUBIAS is an assistant professor of political science, international development and international affairs at the University of Southern Mississippi. He is also a member of the governing board of the National Social Science Association. He has published several works in the field of security studies and American foreign policy, most recently including a coauthored book, *To Protect and Defend: U.S. Homeland Security Policy* (Ashgate, 2006), and an edited volume, *Strategic Interests in the Middle East: Opposition or Support for U.S. Foreign Policy* (Ashgate, 2007). He is also coeditor of the forthcoming volume *America's War on Terror: A Reader*, second edition (Ashgate, 2009).

JOHN J. DIIULIO JR. is the Frederic Fox Leadership Professor of Politics, Religion, and Civil Society at the University of Pennsylvania. He has directed public policy research centers at Princeton University, the Brookings Institution, the Manhattan Institute, and Public/Private Ventures. In 2001, he served as assistant to President George W. Bush and first director of the White House Office of Faith-Based and Community Initiatives. He is author or coauthor of books, including *Godly Republic: A Centrist Blueprint for America's Faith-Based Future* (University of California Press, 2007) and *Fine Print: The Contract with America, Devolution, and the Administrative Realities of American Federalism* (Brookings Institution Press, 1995), with Donald F. Kettl.

WILLIAM A. GALSTON holds the Ezra Zilkha Chair in Governance Studies at the Brookings Institution and is College Park Professor at the University of Maryland. He is a former policy advisor to President Clinton and presidential candidates, as well as an expert on domestic policy, political campaigns, and elections. His current research focuses on designing a new social contract and the implications of political polarization. He

has authored numerous books and articles in political theory, American politics, and public policy, including *The Practice of Liberal Pluralism* (Cambridge University Press, 2005) and *Public Matters: Essays on Politics, Policy and Religion* (Rowman & Littlefield, 2005).

FREDERICK M. HESS is director of education policy studies at the American Enterprise Institute (AEI) and executive editor of *Education Next*. His many books include *When Research Matters* (Harvard Education Press, 2008), *No Remedy Left Behind* (AEI, 2007), *No Child Left Behind: A Primer* (Peter Lang, 2006), *Revolution at the Margins* (Brookings Institution Press, 2002), and *Spinning Wheels* (Brookings Institution Press, 1998). He holds an M.Ed. in teaching and curriculum and an M.A. and Ph.D. in government from Harvard University. Prior to joining AEI, Hess taught high school in Louisiana and was a professor of education and politics at the University of Virginia.

KAREN M. HULT is professor of political science at Virginia Polytechnic Institute and State University. Her primary research interests are the U.S. executive, organization theory and institutional design, and social science methodologies. She is the author or coauthor of numerous works, including *Empowering the White House: Governance Under Nixon, Ford and Carter* (University Press of Kansas, 2004), *Governing the White House: From Hoover Through LBJ* (University Press of Kansas, 1995), and *Governing Public Organizations* (Brooks/Cole, 1990). She is a past president of the American Political Science Association's Presidency Research Group, on the editorial boards of *Congress and the Presidency* and *Rhetoric and Public Affairs*, and book review editor of *Presidential Studies Quarterly*.

LORI A. JOHNSON is an assistant professor in the Department of Political Science at Mercer University in Macon, Georgia. She has published works on comparative regulation and court rule-making. In addition, she has coauthored a chapter on the federal courts and the George W. Bush administration in *The Second Term of George W. Bush* (Palgrave Macmillan, 2006). She won the American Political Science Association's Corwin Award for her dissertation on policy making for the federal courts, which she is currently revising for publication. She obtained her Ph.D.

from the University of California, Berkeley, in 2003 and a J.D. from the University of Virginia in 1989.

ROBERT G. KAUFMAN is professor of public policy at the Pepperdine School of Public Policy. He specializes in American foreign policy, national security, international relations, and various aspects of American politics. Kaufman received his J.D. from Georgetown University Law School and his Ph.D. from Columbia University. He has written numerous works, including *In Defense of the Bush Doctrine* (University Press of Kentucky, 2008), *Arms Control During the Pre-Nuclear Era* (Columbia University Press, 1990), and *Henry M. Jackson: A Life in Politics* (University of Washington Press, 2000), which received the Emil and Katherine Sick Award for the best book on the history of the Pacific Northwest.

ANNE M. KHADEMIAN is associate professor with Virginia Tech's Center for Public Administration and Policy, Alexandria Center. She received her Ph.D. in political science from Washington University in St. Louis and was a research fellow at the Brookings Institution. She is the author of *The SEC and Capital Market Regulation: The Politics of Expertise* (University of Pittsburgh Press, 1992), *Checking on Banks: Autonomy and Accountability in Three Federal Agencies* (Brookings Institution Press, 1996), and *Working with Culture: The Way the Job Gets Done in Public Programs* (CQ Press, 2002), and coauthor of *The Enduring Debate: Classic and Contemporary Readings in American Politics* (Norton, 2000), as well as author of numerous articles in public policy and public management.

LAWRENCE J. KORB is senior fellow at the Center for American Progress and senior advisor to the Center for Defense Information. Before that, he was a senior fellow and director of national security studies at the Council on Foreign Relations. From July 1998 to October 2002, he was council vice president, director of studies, and holder of the Maurice Greenberg Chair. Korb was assistant secretary of defense (manpower, reserve affairs, installations and logistics) from 1981 through 1985. His publications include *A New National Security Strategy in an Age of Terrorists, Tyrants, and Weapons of Mass Destruction: Three Options Presented as Presidential Speeches* (Council on Foreign Relations Press, 2003).

PATRICK J. MCGUINN is an assistant professor of political science at Drew University. His research interests are in national politics and institutions, education and social welfare policy, American political development, federalism, and the policy-making process. His first book, *No Child Left Behind and the Transformation of Federal Education Policy, 1965–2005* (University Press of Kansas, 2006), was honored as a Choice Outstanding Academic Title. McGuinn also has written several peer-reviewed publications, including “The Policy Landscape of Educational Entrepreneurship,” in *Educational Entrepreneurship: Realities, Challenges, and Possibilities*, edited by Frederick Hess (Harvard Education Press, 2006).

MICHAEL P. MORELAND is assistant professor of law at Villanova University. Before joining the Villanova faculty, he was associate director for domestic policy at the White House, where he was responsible for coordinating policy development on a range of legal issues, including immigration, crime, civil rights, and tort reform. He has published and spoken on tort law, law and religion, and bioethics. Moreland’s publications include “Subsidiarity, Localism and School Finance,” *Journal of Catholic Social Thought* 369(2) (2005), and “Jacques Maritain, Thomism, and the Liberal-Communitarian Debate,” in *The Failure of Modernism: The Cartesian Legacy and Contemporary Pluralism*, edited by Brendan Sweetman (American Maritain Association, 1999).

COSTAS PANAGOPOULOS is assistant professor of political science and director of the Center for Electoral Politics and the master’s program in elections and campaign management at Fordham University. His academic research focuses on American politics, with an emphasis on campaigns and elections, voting behavior, public opinion and Congress, and has been published in the *American Journal of Political Science*, *Public Opinion Quarterly*, *Presidential Studies Quarterly*, *Electoral Studies*, and *PS: Political Science and Politics*. He is editor of *Rewiring Politics: Presidential Nominating Conventions in the Media Age* (Louisiana State University Press, 2007) and coauthor of *All Roads Lead to Congress: The \$300 Billion Fight over Highway Funding* (CQ Press, 2007).

JAMES P. PFIFFNER is currently professor in the School of Public Policy at George Mason University and has occupied a number of academic

and professional positions. He has written or edited twelve books on the presidency and American national government, including *The Strategic Presidency: Hitting the Ground Running*, second edition (University Press of Kansas, 1996), *The Modern Presidency*, fourth edition (Wadsworth, 2004), *The Character Factor: How We Judge Our Presidents* (Texas A&M University Press, 2004), and *Power Play: The Bush Administration and the Constitution* (Brookings Institution Press, 2008), as well as *Understanding the Presidency*, cocited with Roger H. Davidson (HarperCollins, 1997).

RICHARD E. REDDING is professor of law at Chapman University Law School. He has produced numerous scholarly works, including *Juvenile Delinquency: Assessment, Prevention, and Intervention* (Oxford University Press, 2005) and *The Politically Correct University* (AEI, 2009). Redding was professor of law at Villanova University, research professor of psychology at Drexel University, and director of the J.D./Ph.D. program in law and psychology at Villanova and Drexel Universities. He was also assistant professor and associate director of the Institute of Law, Psychiatry, and Public Policy at the University of Virginia School of Law, teaching on a range of subject areas.

NEIL REEDY holds a bachelor's degree in both history and political science and a master's degree in political science from Villanova University, where he authored the paper "Judging the Presidency: Foreign Policy as the Dominant Criteria." He has also contributed articles to a political website and has publications in the journal *Intelligence and National Security* (forthcoming) and a coauthored chapter, "The Evolution of Homeland Security and the War on Terror," in *America's War on Terror: A Reader*, second edition (Ashgate, 2009). ANDREW RUDALEVIGE is the Walter Beach '56 Distinguished Chair in Political Science at Dickinson College in Carlisle, Pennsylvania. He is the author, coauthor, or editor of several books, including *The George W. Bush Legacy* (CQ Press, 2007), *The New Imperial Presidency: Renewing Presidential Power After Watergate* (University of Michigan Press, 2005), and *Managing the President's Program* (Princeton University Press,

2002). The latter won the Richard E. Neustadt Award as that year's best book on the presidency. In addition, Rudalevige has produced a number of scholarly journal articles, including "The Structure of Leadership: Presidents, Hierarchies, and Information Flow," *Presidential Studies Quarterly* 35 (June 2005).

CHARLES E. WALCOTT is professor of political science at Virginia Polytechnic Institute and State University. His research interests are political organizations and the institution of the U.S. presidency. He has written, co-written, or edited five books with Karen M. Hult, including *Empowering the White House: Governance Under Nixon, Ford and Carter* (University Press of Kansas, 2004), *Governing the White House: From Hoover Through LBJ* (University Press of Kansas, 1995), and *Governing Public Organizations* (Brooks/Cole, 1990). He also has produced or contributed to a number of scholarly essays. Walcott's articles have appeared in the *American Journal of Political Science*, *Congress and the Presidency*, *Polity*, *Presidential Studies Quarterly*, and other scholarly journals.

SHIRLEY ANNE WARSHAW is professor of political science at Gettysburg College, Gettysburg, Pennsylvania. She is the author of numerous books, including *The Clinton Years* (Checkmark, 2004), *The Keys to Power: Managing the Presidency*, second edition (Longman, 2005; 1st ed. 1999), *The Domestic Presidency: Decision Making in the White House* (Longman, 1996), *Powersharing: White House–Cabinet Relations in the Modern Presidency* (SUNY Press, 1996), *Reexamining the Eisenhower Presidency* (Greenwood, 1993), and *The Eisenhower Legacy* (Bartleby, 1991). She has recently written a book entitled *The Co-Presidency of Bush and Cheney* (Stanford University Press, 2009). Her research interests are concentrated on organizational decision structures for presidential decision making.
