LAURA J. ARRIAZA is a JD candidate at the Washington College of Law at the American University. She was a 2008 Fulbright Fellow in Guatemala, conducting field research on reparations, and graduated from Tufts University with a Bachelor of Arts in 2005. She currently resides in Washington, D.C.

HILLEL COHEN is a research fellow at the Truman Institute for the Advancement of Peace at the Hebrew University of Jerusalem, where he also teaches history. His recent publications include *Good Arabs: The Israeli Security Agencies and the Israeli Arabs, 1948–1967* (2010) and *Army of Shadows: Palestinian Collaboration with Zionism 1917–1948* (2008).

RON DUDAI is a policy adviser at Amnesty International and is a visiting lecturer at the Centre for Applied Human Rights at the University of York (UK). Previously, he was a researcher at B'tselem, the leading human rights NGO working on the Israeli-Palestinian conflict. He conducted research for this volume when he was Chapman Visiting Fellow at the Institute of Commonwealth Studies at the University of London. In 2004, he was a Transitional Justice Fellow at the Institute for Justice in Reconciliation in South Africa, cosponsored by the International Center for Transitional Justice, and from 2004 to 2007 he was Research Fellow at the Programme in Law and Human Rights in the Middle East at the School of Oriental and African Studies at the University of London.

PATRICK FALVEY has worked with Burmese human rights groups in Thailand since 1998. He has initiated and managed projects on documentation of human rights violations, transitional justice trainings, and research among

people affected by human rights violations in Burma. Working in a pre-transition setting, he explores the efficacy of applying a transitional justice framework to an ongoing conflict. Falvey holds a Master of Arts degree in applied anthropology from the American University.

SVERKER FINNSTRÖM is associate professor (docent) in cultural anthropology. Starting from 1997, Finnström has conducted recurrent fieldwork in Acholiland, northern Uganda, with a focus on young adults living in the immediate shadows of war. He divides his time between Stockholm University, where he teaches anthropology, and The Hugo Valentin Center of Uppsala University, where he is a researcher in political violence and genocide studies. Finnström is the author of *Living with Bad Surroundings: War, History, and Everyday Moments in Northern Uganda* (Duke University Press, 2008), for which he was honored with the 2009 Margaret Mead Award.

LAUREL E. FLETCHER is a clinical professor of law and director of the International Human Rights Law Clinic at the School of Law at the University of California, Berkeley. She utilizes an interdisciplinary, problem-based approach to human rights research, advocacy, and policy. Her current publications include *The Guantánamo Effect: Exposing the Consequences of U.S. Detention and Interrogation Practices* (2009), coauthored with Eric Stover. This book provides the findings of a two-year study of former detainees who were held in U.S. custody in Afghanistan and Guantánamo Bay, Cuba.

PIERRE HAZAN is a visiting professor at the Graduate Institute for International and Development Studies in Geneva, Switzerland. He worked in the UN Office of the High Commissioner for Human Rights (2008–9), including as a political advisor to the High Commissioner. Pierre Hazan has held a Jennings Randolph Senior Fellowship at the United States Institute of Peace in Washington, D.C. (2005–6) and a Fellowship at Harvard Law School (2004–5). For fifteen years, he was the UN Diplomatic Correspondent in Geneva for the French daily *Liberation* and with the Swiss *Le Temps*. His recent publications include *Judging War, Judging History: Behind Truth and Reconciliation* (2010), and *Justice in a Time of War* (2004). He also produced a number of TV documentaries on universal jurisdiction and on the International Criminal Tribunal for Rwanda.

ANN NEE is an associate at Cleary Gottlieb Steen & Hamilton LLP in New York City. She received a JD from Harvard Law School and an MALD from the Fletcher School of Law and Diplomacy, Tufts University.

MOSES CHRISPUS OKELLO holds a Master's in International Human Rights Law and a post-graduate diploma in Forced Migration Refugee Studies. He is currently head of the Research and Advocacy Department at the Refugee Law Project, within which he also coordinates the Beyond Juba Project (www.beyondjuba.org), a transitional justice project of the Refugee Law Project (RLP) and The Human Rights and Peace Centre (HURIPeC), all of the Faculty of Law, Makerere University. Moses' involvement with the African Transitional Justice Research Network (ATJRN) has seen him engage with organizations in Africa (in particular West, East, and Southern Africa) and beyond the continent. He has contributed book chapters, published in international peer reviewed journals, and is a member of the Editorial Board of the *International Journal of Transitional Justice*. His research interests include conflict analysis, forced migration, transitional justice, gender, and international human rights law more broadly.

PHUONG N. PHAM is director of research and visiting associate professor at the University of California's Human Rights Center and International and Area Studies, and adjunct associate professor at the Payson Center for International Development, Tulane University. A social epidemiologist, Pham works internationally to examine the consequences of war, disasters, mass violence and human rights violations, and the impact of reconstruction policies. She has recently completed work in Rwanda, Iraq, northern Uganda, Democratic Republic of Congo, Cambodia, and post-Katrina New Orleans. Pham also worked with schools of public health in Vietnam, Rwanda and DRC, supporting institutional, faculty, and curriculum development.

NAOMI ROHT-ARRIAZA is a professor of law at the University of California, Hastings College of the Law in San Francisco. She is the author of *Impunity and Human Rights in International Law and Practice* (1995) and *The Pinochet Effect: Transnational Justice in the Age of Human Rights* (2005), and co-editor of *Transitional Justice in the Twenty-First Century: Beyond Truth versus Justice* (2006) as well as numerous law review articles on transitional justice, international criminal accountability, universal jurisdiction, and reparations issues.

She has worked extensively in Latin America, participated as an expert witness in cases filed under the Alien Tort Statute, and has been a project adviser and participant for the International Center of Transitional Justice. She is a National Board Member of Human Rights Advocates, and a member of the legal advisory board of the Center for Justice and Accountability, where she advises on universal jurisdiction cases, especially the Guatemala Genocide case.

FIONA C. ROSS is an associate professor of social anthropology at the University of Cape Town in South Africa. She has published widely on the Truth and Reconciliation Commission in South Africa, including a monograph, *Bearing Witness: Women and the Truth and Reconciliation Commission in South Africa* (2003). Her latest book, *Raw Life, New Hope*, a study of everyday life in a shanty town on the outskirts of Cape Town was published in 2009.

ROSALIND SHAW is an associate professor of anthropology at Tufts University. Recent awards include a Jennings Randolph Senior Fellowship at the U.S. Institute of Peace, a MacArthur Foundation Research and Writing Grant, and a Fellowship at the Carr Center for Human Rights Policy at Harvard University. Her recent publications include "Memory Frictions: Localizing Truth and Reconciliation in Sierra Leone," *International Journal of Transitional Justice* (2007); "Displacing Violence: Making Pentecostal Memory in Postwar Sierra Leone," *Cultural Anthropology* (2007); and *Memories of the Slave Trade: Ritual and the Historical Imagination in Sierra Leone* (2002).

RUTI G. TEITEL is Ernst C. Stiefel Professor of Comparative Law at New York Law School. She was a Senior Fellow at the Orville H. Schell, Jr. Center for International Human Rights at Yale Law School, is a member of the Council on Foreign Relations, and a member of the Steering Committee of Human Rights Watch Europe/Central Asia. Her recent publications include the critically acclaimed book *Transitional Justice* (2000), as well as articles published in the *Yale Law Journal*, the *Harvard Law Review*, the *New York Times*, and *Legal Affairs*, and at findlaw.com.

KIMBERLY THEIDON is a medical anthropologist focusing on Latin America. Her research interests include critical theory applied to medicine, psychology, and anthropology, domestic, structural, and political violence, transitional

justice, reconciliation, and the politics of postwar reparations. She is the author of *Entre Prójimos: El conflicto armado interno y la política de la reconciliación en el Perú* (2004) and *Intimate Enemies: Violence and Reconciliation in Peru* (Stanford University Press, forthcoming). She is currently involved in two research projects. She is completing research on “Transitional Subjects: The Disarmament, Demobilization, and Reintegration of Former Combatants in Colombia,” in which she works with former combatants from the paramilitaries, the FARC, and the ELN. In Peru, she is conducting “El Dorado: Coca, Conflict and Control in the Apurímac and Ene River Valley,” an ethnographically-grounded study of alternative development and forms of governmentality in the foremost coca growing region of Peru. Dr. Theidon is an associate professor of anthropology at Harvard University, and the director of Praxis Institute for Social Justice.

PETER UVIN is academic dean and Henry J. Leir Professor of International Humanitarian Studies at the Fletcher School. He has written extensively on the intersection of human rights, development, and conflict resolution and has been a frequent consultant to agencies working in Africa on these same issues. In 2006–7, he received a Guggenheim Fellowship. His recent publications include *Life After Violence: A People’s History of Burundi* (2008), *Human Rights and Development* (2004), and *Aiding Violence: The Development Enterprise in Rwanda* (1998).

PATRICK VINCK is the director of the Initiative for Vulnerable Populations at the University of California, Berkeley’s Human Rights Center, and adjunct associate professor at the Payson Center for International Development, Tulane University. Vinck holds a degree in agricultural engineering and a Ph.D. in International Development. His research lies at the nexus between war and complex emergencies, peace building, international development, public policy, and vulnerability analysis. He has developed and managed rural development projects in Africa, and, most recently, conducted research on conflicts and transition in the Central African Republic, Democratic Republic of Congo, and Uganda.

LARS WALDORF is a senior lecturer in the Centre for Applied Human Rights at the University of York (UK). He was a Fellow at the Human Rights Program at Harvard Law School after running Human Rights Watch’s field office in

Rwanda (2002–4) and covering genocide trials at the United Nations International Criminal Tribunal for Rwanda (2001). He is writing a book on Rwanda's community genocide trials (*gacaca*) with support from the United States Institute of Peace. He previously taught at The New School and Harvard. Before becoming a human rights advocate, he litigated civil rights cases in the U.S. for nine years. His publications include several reports, articles, and book chapters on Rwanda and transitional justice.

HARVEY M. WEINSTEIN is Senior Research Fellow at the Human Rights Center of the University of California, Berkeley, and a clinical professor in the School of Public Health. He was associate director of the Human Rights Center from 1998 to 2005, where he directed the Forced Migration and Health Project from 1997 to 1999 and was co-principal investigator on three other projects. In 2005, he was involved in a study of human rights violations after the tsunami in five South Asian countries. He is co-editor of the *International Journal of Transitional Justice*. His recent publications include *My Neighbor, My Enemy: Justice and Community after Mass Atrocity* (2004), coedited with Eric Stover; and *Psychiatry and the CIA: Victims of Mind Control* (1990); as well as recent reports including "After the Tsunami: Human Rights in Vulnerable Populations" and "Iraqi Voices: Attitudes Towards Justice and Social Reconstruction."
