ITTY ABRAHAM is Marlene and Morton Meyerson Centennial Chair and associate professor of government and Asian studies at the University of Texas at Austin. His most recent publication is an edited volume of essays, *South Asian Cultures of the Bomb: Atomic Publics and the State in India and Pakistan* (Indiana University Press, 2008).

KANTI BAJPAI is currently teaching international relations and the politics of contemporary India at Oxford University. He was headmaster of the Doon School, India, and professor of international politics at Jawaharlal Nehru University, New Delhi. He has also taught at the Maharaja Sayajirao University of Baroda, Vadodara, India, and has held visiting positions at Wesleyan University, the University of Illinois, the Rajiv Gandhi Foundation, the University of Notre Dame, the Brookings Institution, and the Australian Defence Force Academy. His research interests are security studies, India's foreign policy and national security, and South Asia.

S. PAUL KAPUR is associate professor in the Department of National Security Affairs at the Naval Postgraduate School. Previously, he was on the faculties of the Naval War College and Claremont McKenna College and was a visiting professor at Stanford University's Center for International Security and Cooperation. He also served as a postdoctoral fellow at the University of Chicago, where he received his Ph.D. in political science. His research and teaching interests include nuclear weapons proliferation, deterrence, ethno-religious violence, and the international security environment in South Asia. Kapur is author of *Dangerous Deterrent: Nuclear Weapons Proliferation and Conflict*

in *South Asia* (Stanford University Press, 2007). His work has also appeared in journals, such as *International Security*, *Security Studies*, *Asian Survey*, and *Asian Security*, and in several edited volumes.

VIPIN NARANG is a Ph.D. candidate in the Department of Government, Harvard University, focusing on nuclear proliferation in regional powers. He holds a B.S. and M.S. in chemical engineering from Stanford University and an M.Phil. with Distinction in international relations from Balliol College, Oxford University, where he studied on a Marshall Scholarship. Starting in the fall of 2010, he will be an assistant professor in the Department of Political Science at the Massachusetts Institute of Technology.

SCOTT D. SAGAN is a professor of political science at Stanford University and co-director of Stanford's Center for International Security and Cooperation. Sagan has authored a number of books on nuclear weapons and international security, including *Moving Targets: Nuclear Strategy and National Security* (Princeton University Press, 1989) and *The Limits of Safety: Organizations, Accidents, and Nuclear Weapons* (Princeton University Press, 1993), winner of the American Political Science Association's award for Best Book in Science, Technology, and Environmental Studies. He also co-authored *The Spread of Nuclear Weapons: A Debate Renewed* (W. W. Norton, 2002) with Kenneth N. Waltz.

KARTHIKA SASIKUMAR is an Assistant Professor in the Political Science Department at San Jose State University. She has been a Postdoctoral Fellow at the University of British Columbia's Liu Institute for Global Issues, an Associate in the International Security Program at Harvard University's Kennedy School of Government, and a Predoctoral Fellow at the Center for International Security and Cooperation, Stanford University. She completed her M.Phil. at Jawaharlal Nehru University, New Delhi and her Ph.D. at Cornell University. Her research interests are in international relations theory, international regimes in the areas of nuclear weapons and terrorism, and South Asia.

CHRISTOPHER WAY is an associate professor of government at Cornell University. His research and teaching interests include international/comparative political economy, international relations, and nuclear proliferation. Way's current research focuses on the proliferation of weapons of mass destruction and the effectiveness of the nonproliferation regime, topics on which he has published several journal articles and book chapters.
