Stuart W. Bowen, Jr., is Special Inspector General for Iraq Reconstruction. He was appointed Inspector General for the Coalition Provisional Authority in January 2004. Mr. Bowen is the primary author of *Hard Lessons: The Iraq Reconstruction Experience*. Prior to his appointment as Inspector General, he served in the White House as Deputy Assistant to the President, Deputy Staff Secretary, Special Assistant to the President, and Associate Counsel. He holds a B.A. from the University of the South and a J.D. from St. Mary's Law School.

Frank Camm is a Senior Economist at the RAND Corporation, where he has spent most of his career since 1976. He is the author of numerous books on managing risk in the military. Kateri Carmola is an Associate Professor of Political Science at Middlebury College, Vermont. She is the author of *Private Security Contractors and New Wars: Risk, Law, and Ethics* (Routledge, 2010). Dr. Carmola has participated in forums on private security contracting hosted by the American Bar Association, the Princeton Project on National Security, and Harvard University Law

School. Her opinions have been sought by the UN Working Group on Mercenaries, National Public Radio, and the *New York Times*.

Geoffrey S. Corn is a Professor of Law at South Texas College of Law in Houston, Texas, a retired US Army Lieutenant Colonel, and formerly the Special Assistant to the US Army Judge Advocate General for Law of War Matters. He is the lead author of *The Laws of War and the War on Terror*, published by Oxford University Press; and a co-author of *Principles of Counter-Terrorism Law*, published by Thompson-West.

Renée de Nevers is Associate Professor in the Department of Public Administration and International Affairs in the Maxwell School at Syracuse University. Her previous books include *Combating Terrorism* (with William C. Banks and Mitchel Wallerstein, Congressional Quarterly Press, 2008) and *Comrades No More: The Seeds of Change in Eastern Europe* (MIT Press, 2003).

Colonel William J. Flavin (ret'd) is Directing Professor in the Doctrine, Concepts, Training and Education Division, Peacekeeping and Stability Operations Institute, U.S. Army War College, Carlisle, Pennsylvania. He is a past senior fellow at the Center for Strategic and International Studies (CSIS), and a senior foreign affairs analyst with Booz Allen and Hamilton. He holds a BA in History from VMI and an MA in History from Emory University. His most recent publication is *Finding the Balance: U.S. Military and Future Operations* (PKSOI, 2011).

The Honorable *Jacques S. Gansler* is a former Under Secretary of Defense for Acquisition, Technology, and Logistics. He holds the Roger C. Lipitz Chair in Public Policy and Private Enterprise in the School of Public Policy, and is the Director of the Center for Public Policy and Private Enterprise at the University of Maryland. Before joining the Clinton administration, he held a variety of senior positions in government and the private sector. He is the author of *The Defense Industry* (1980), *Affording Defense* (1989), *Defense Conversion* (1995), *Democracy's Arsenal* (2011) [all MIT Press]; and *Ballistic Missile Defense* (2010, NDU Press). Professor Gansler has contributed 25 book chapters and authored over 100 papers.

Ryan Kelty is Associate Professor of Sociology in the Department of Sociology and Anthropology at Washington College. He teaches courses on Armed Forces and Society, Social Inequalities, Death and Dying, and Environmental Sociology. He is co-editor, with Morten Ender and Lynn Woehrle, of *Teaching the Sociology of Peace, War, and Military Institutions* (American Sociological

Association, 2007). Dr. Kelty's research interests include civilianization of the military, diversity in the military, social identity, and environmental sociology.

Christopher Kinsey is a Senior Lecturer in International Security with King's College London. Based in the Defence Studies Department at the Joint Services Command and Staff College, he teaches military officers from around the world. His research interest is the role of contractors in war. Dr. Kinsey has published widely on this subject in leading academic journals and his previous books include *Corporate Soldiers and International Security* (Routledge, 2006), and *Private Contractors and the Reconstruction of Iraq: Transforming Military Logistics* (Routledge, 2009).

William Lucyshyn is the Director of Research and Senior Research Scholar at the Center for Public Policy and Private Enterprise in the School of Public Policy at the University of Maryland. He is responsible for directing research on public sector management and operations, and how government works with private enterprise. He has authored numerous reports, book chapters, and journal articles. Mr. Lucyshyn is a past research director, program manager, and the principal technical advisor to the Director of the Defense Advanced Research Projects Agency (DARPA).

Robert Mandel is Chair and Professor of International Affairs at Lewis & Clark College in Portland, Oregon. He is the author of ten books and over forty articles and book chapters on security and conflict issues. His latest book is *Dark Logic: Transnational Criminal Tactics and Global Security* (Stanford University Press, 2011). He has just finished another book manuscript, titled *Global Security Upheaval: Armed Non-State Groups Usurping State Stability Functions*. He has testified before the United States Congress and worked for several government intelligence agencies.

Malcolm Hugh Patterson is an Australian lawyer who teaches international law and international relations. Since the award of his PhD from the University of Cambridge in 2008 he has taught at the University of New South Wales and Macquarie University in Sydney. He is the author of *Privatising Peace: A Corporate Adjunct to United Nations Peacekeeping and Humanitarian Operations* (Palgrave, 2009), and has published in the *Journal of Conflict and Security Law* and contributed a chapter to *The Global Arms Trade: A Handbook*.

Congressman David E. Price represents the Fourth District of North Carolina. Prior to entering Congress in 1987, he was a professor of political science and

public policy at Duke University. He has authored four books on Congress and the American political system and currently serves on the House Appropriations Committee and is the ranking member of the Homeland Security Appropriations Subcommittee. Dr. Price is a recognized leader in foreign policy and co-chairs the House Democracy Partnership, which he initiated to strengthen parliaments in emerging democracies.

Darcy Schnack is a logistics Major in the US Army and currently attends the Army Command and General Staff College at Ft. Leavenworth, Kansas. Major Schnack graduated from West Point in 1996 and since then has been on active duty, serving two tours in Iraq in addition to several stateside locations. Major Schnack earned her MA in Sociology from Boston College, where she will begin her PhD studies in January 2012, examining civil–military relations and military sociology.

Allison Stanger is the Russell Leng '60 Professor of International Politics and Economics and Chair of the Political Science Department at Middlebury College. Her most recent book, *One Nation Under Contract: The Outsourcing of American Power and the Future of Foreign Policy*, was published by Yale University Press in fall 2009 (with a paperback edition in January 2011). In 2010, Stanger testified on contracting issues before the Commission on Wartime Contracting, the Senate Budget Committee, and the Congressional Oversight Panel. From 2009 to 2011, she served as an advisor to the Secretary's Policy Planning Staff, US Department of State. Stanger received her PhD in Political Science from Harvard University.

Since his arrival, *Samuel Worthington* has led InterAction to renewed prominence as a vibrant and vital force advocating globally on behalf of the world's poor and vulnerable, protecting NGO and civil society space, and promoting partnership with multiple actors as a means of addressing poverty, environmental impact and food security, human rights and more. Previous leadership roles include chairing the global NGO Impact Initiative on behalf of the office of the UN Special Envoy for Tsunami Recovery (President Clinton) and co-founding the Hope for African Children Initiative (HACI), a partnership of NGOs working to address the impact of AIDS on children.
