Mark W. Frazier (PhD, Political Science, University of California, Berkeley) is the ConocoPhillips Professor of Chinese Politics and Associate Professor of International and Area Studies at the University of Oklahoma. His research examines the politics of labor and social policy in China. He is the author of *Socialist Insecurity: Pensions and the Politics of Uneven Development in China* (Cornell University Press, 2010) and *The Making of the Chinese Industrial Workplace: State, Revolution, and Labor Management* (Cambridge University Press, 2002).

Gregory J. Kasza (PhD, Political Science, Yale University) is Professor in the Departments of East Asian Languages & Cultures and Political Science at Indiana University. His scholarship analyzes Japanese politics from a broad comparative perspective, and his interests include state–society relations, war and politics, fascism, and welfare policy. He is the author of *The State and the Mass Media in Japan, 1918–1945* (University of California Press, 1988), *The Conscription Society* (Yale University Press, 1995), and *One World of Welfare: Japan in Comparative Perspective* (Cornell University Press, 2006).

Scott Kennedy (PhD, Political Science, George Washington University) is Associate Professor, Departments of East Asian Languages & Cultures and Political Science; and Director, Research Center for Chinese Politics and Business, Indiana University. He is author of *The Business of Lobbying in China* (Harvard University Press, 2005) and editor of *China Cross Talk: The American Debate over China Policy since Normalization, A Reader* (Rowman & Littlefield, 2003). His current research projects are on the growing role of Chinese industry and government in global governance and on the evolution of corporate political activity in China.

Arthur R. Kroeber (AB, Harvard University) is editor of the *China Economic Quarterly* and managing director of GKDragonomics, an economic research firm specializing in China and its impact on the world economy.

Margaret M. Pearson (PhD, Political Science, Yale University) is Professor of Government and Politics at the University of Maryland, College Park. She has focused her research on China's domestic and international political economy. Her publications include the books *Joint Ventures in the People's Republic of China* (Princeton University Press, 1991) and *China's New Business Elite: The Political Results of Economic Reform* (University of California Press, 1997). Her numerous other publications include articles in *World Politics*, *Public Administration Review*, *The China Journal*, *Modern China*, and *China Business Review*. Her most recent work is on China's role in the WTO and on the politics of economic regulation in China.

Victor Shih (PhD, Government, Harvard University) is an Associate Professor of Political Science at Northwestern University specializing in China. An immigrant to the United States from Hong Kong, Dr. Shih researched banking sector reform in China with the support of the Jacob K. Javits Fellowship and the Fulbright Fellowship while a doctoral student at Harvard. He is the author of *Factions and Finance in China: Elite Conflict and Inflation* (Cambridge University Press, 2008). It is the first book to inquire into the linkages between elite politics and banking policies in China. He is also the author of numerous articles appearing in academic and business journals, including *The China Quarterly*, *Comparative Political Studies*, and *The Far Eastern Economic Review*, and is a frequent adviser to the private sector on the banking industry in China. His current research concerns elite political dynamics in China and Chinese policies toward ethnic minorities.

Kellee S. Tsai (PhD, Political Science, Columbia University) is Professor of Political Science and Vice Dean for Humanities, Social Sciences, and Graduate Programs at Johns Hopkins University. Her most recent book is *Capitalism without Democracy: The Private Sector in Contemporary China* (Cornell University Press, 2007). She is also the author of *Back-Alley Banking: Private Entrepreneurs in China* (Cornell University Press, 2002), coauthor of *Rural Industrialization and Non-Governmental Finance: Insights from Wenzhou* (Shanxi Economics Press, 2004), coeditor of *Japan and China in the World*

Political Economy (2005), and author of various journal articles. Tsai's professional experience includes working at Morgan Stanley and Women's World Banking and consulting for the World Bank's Consultative Group to Assist the Poorest and various other organizations.

Andrew Wedeman (PhD, Political Science, UCLA) is Professor, Department of Political Science, University of Nebraska. He has served as a visiting professor at the Johns Hopkins–Nanjing University Center for Chinese and American Studies, a visiting Fulbright Researcher at National Taiwan University, and a visiting scholar at Peking University. His research focuses on the political economy of reform in China and specifically on the relationship between corruption and development, both in China and elsewhere in the developing world. His publications include *The Double Paradox of Corruption and Rapid Development in China* (Cornell University Press, forthcoming), *From Mao to Market: Rent Seeking, Local Protectionism, and Marketization in China* (Cambridge University Press, 2003) and articles in *China Quarterly*, the *Journal of Contemporary China*, and the *China Review*.
