Keith Michael Baker is the J. E. Wallace Sterling Professor in Humanities and Professor of History at Stanford University and the Jean-Paul Gimon Director of the France-Stanford Center for Interdisciplinary Studies. His publications include *Condorcet: From Natural Philosophy to Social Mathematics* (1975); *Inventing the French Revolution: Essays on French Political Culture in the Eighteenth Century* (1990); and "Political Languages of the French Revolution," in *The Cambridge History of Eighteenth-Century Political Thought*, ed. Mark Goldie and Robert Wokler (2006). He has edited a collection of documents, *The Old Regime and the French Revolution* (1987), and a translation of *Condorcet: Selected Writings* (1976). Other edited works include *The French Revolution and the Creation of Modern Political Culture*, vol. 1: *The Political Culture of the Old Regime* (1989) and vol. 4: *The Terror* (1994). With Peter Reill, he is the editor of *What's Left of Enlightenment? A Post-Modern Question* (2010).

Gail Bossenga, Associate Professor of History and Director of European Studies at the College of William and Mary, received her Ph.D. from the University of Michigan. She has published numerous articles and book chapters dealing with French finances, guilds, corporate politics, and notions of citizenship in the Old Regime and French Revolution. Author of *The Politics of Privilege: Old Regime and Revolution in Lille* (1991), she is currently working on a book analyzing institutional origins of the French Revolution.

Jack A. Goldstone is Hazel Professor of Public Policy and a Fellow of the Mercatus Center at George Mason University. He received his Ph.D. from Harvard University. He has won major prizes from the American Sociological Association and the Historical Society for his research on

revolutions and social change, and has won grants from the American Council of Learned Societies, the MacArthur Foundation, the U.S. Institute of Peace, the Canadian Institute for Advanced Research, and the National Science Foundation. Goldstone has authored or edited ten books and published over one hundred articles in books and scholarly journals. His latest book is *Why Europe? The Rise of the West 1500–1850* (2008).

Thomas E. Kaiser, Professor of History at the University of Arkansas at Little Rock, received his Ph.D. from Harvard University. He has received many grants and fellowships and has published widely on many aspects of the political culture of the Old Regime and French Revolution, including government propaganda, finance, property, historiography, royal women, and most recently, diplomacy. In addition to twenty-five articles and book chapters, he is a co-author of *Europe, 1648–1815: From the Old Regime to the Age of Revolution* (2004) and co-editor of *Conspiracy in the French Revolution* (2007). He is working on a monograph provisionally entitled *Devious Ally: Marie-Antoinette and the Austrian Plot, 1748–1794*.

Jeffrey Merrick, Professor of History and Associate Dean for the Humanities at the University of Wisconsin-Milwaukee, received his Ph.D. from Yale University. He is the author of *The Desacralization of the French Monarchy in the Eighteenth Century: Order and Disorder under the Ancien Régime* (1990), and many articles on gender, suicide, sexuality, and political culture in early modern France, and is co-editor of several volumes on homosexuality in French history and of *Family, Gender, and Law in Early Modern France* (2009). He has served as president of the Society for French Historical Studies and the Western Society for French History.

Jeremy D. Popkin, T. Marshall Hahn Jr. Professor of History at the University of Kentucky, has written numerous books on the French and Haitian Revolutions and the subject of autobiographical literature, including *You Are All Free: The Haitian Revolution and the Abolition of Slavery* (2010); *Revolutionary News: The Press in France, 1789–1799* (1990); *Facing Racial Revolution: Eyewitness Accounts of the Haitian Revolution* (2007); and *History, Historians and Autobiography* (2005).

Dale K. Van Kley, Professor of Early Modern European History, Ohio State University, has published and edited several books and published many articles. Among the books is *The Religious Origins of the French Revolution: From Calvin to the Civil Constitution of the Clergy, 1560–1791* (1996) [French translation: *Les origines de la Révolution française, 1560–1791* (2003)]. Among his edited books is *The French Idea of Freedom: The Old Regime and the Declaration of Rights of 1789* (1994). Of his recent articles, “Civic Humanism in Clerical Guise: Gallican Memories of the Early Church and the Project of Primitivist Reform, 1719–1791” (*Past and Present*, [2008], 625–67) best delineates the trajectory of his present book project on Catholic reform in an age of anti-Catholic revolution, 1750–1804.
