Victor Asal is Director of the Center for Policy Research and an Associate Professor in the Department of Political Science at the University at Albany–SUNY. He has been involved in research projects funded by the Defense Advanced Research Projects Agency, Defense Threat Reduction Agency, the Department of Homeland Security, the National Science Foundation, and the Office of Naval Research.

Kyle Beardsley is an Associate Professor of Political Science at Emory University. Beardsley received his Ph.D. from the University of California, San Diego in 2006. In addition to his work on nuclear proliferation, Beardsley maintains an active research agenda on topics related to conflict management and resolution. His book, *The Mediation Dilemma*, was published in 2011.
