Ross Babbage is founder of the Kokoda Foundation, a not-for-profit research corporation that works closely with Australian government agencies on Australia's future security challenges. For the first five years of the foundation's existence, he served as its Chairman and Chief Executive Officer. He served as a special advisor to the Minister for Defense during the preparation of the 2009 Australian Defense White Paper. He also served on the Council of the International Institute for Strategic Studies. In addition, Professor Babbage is Managing Director of Strategy International (ACT) Pty Ltd, a defense consulting and education service delivery organization. He has served as a senior government official, a senior executive in the corporate world and also as a senior academic. Amongst his publications are: *A Coast Too Long: Defending Australia Beyond the 1990s* (Allen & Unwin, 1990) and *Rethinking Australia's Defence* (University of Queensland Press, 1980).

Gordon S. Barrass is a visiting professor dealing with strategic issues at the London School of Economics. During the last years of the Cold War he was Chief of the Assessments Staff in the Cabinet Office in London. He is author of *The Great Cold War: A Journey through the Hall of Mirrors* (Stanford University Press, 2009).

John A. Battilega is a Senior Technical Director of Science Applications International Corporation. He has been a senior consultant to the Office of the Secretary of Defense and the Intelligence Community for thirty years. He

directed strategic research on the Soviet Union, Russia, and Eurasia from 1977–1999. Dr. Battilega was directly involved in the U.S. Competitive Strategies program throughout the decade of the 1980s. He has taught on the graduate faculty of the Graduate School of International Studies, University of Denver, and the U.S. Defense Intelligence College. He is a former Army officer and Vietnam veteran.

Dan Blumenthal is a resident fellow at The American Enterprise Institute for Public Policy Research as well as a current commissioner and former vice chairman of the U.S.–China Economic and Security Review Commission. Previously, he was senior director for China, Taiwan, and Mongolia in the Secretary of Defense’s Office of International Security Affairs and practiced law in New York prior to his government service. At AEI, in addition to his work on the national security implications of U.S.–Sino relations, he coordinates the Tocqueville on China project, which examines the underlying civic culture of post-Mao China. Mr. Blumenthal also contributes to AEI’s *Asian Outlook* series and is a research associate with the National Asia Research Program.

Michael S. Chase is Director of the Mahan Scholars Group at the U.S. Naval War College and previously served on the faculty of the College’s Strategy and Policy Department. Prior to joining the Naval War College, he served as a research analyst with Defense Group Inc. and the RAND Corporation. He is the author of the book *Taiwan’s Security Policy: External Threats and Domestic Politics* (Lynne Rienner, 2008). His recent publications include studies on Chinese nuclear force modernization and strategy, defense reform and domestic politics in Taiwan, Taiwan’s defense spending debate, and contemporary U.S.–Taiwan security cooperation.

Owen R. Coté Jr. is Associate Director of the MIT Security Studies Program. He is also coeditor of the journal *International Security*. He received his PhD in Political Science from MIT, where he specialized in U.S. defense policy and international security affairs. He has written on U.S. nuclear weapons policy, avoiding nuclear terrorism, the sources of innovation in military doctrine, the future of naval warfare, and is also the author of *The Third Battle* (Naval War College Press, 2003), a history of how the U.S. Navy performed antisubmarine warfare during the Cold War.

Jacqueline Newmyer Deal is President and CEO of the Long Term Strategy Group, a Cambridge, Massachusetts-based defense consultancy. For the last five years, she has worked with the Director of the Office of the Secretary of Defense/Net Assessment on projects related to East Asia. She has held post-doctoral fellowships at the Belfer Center for Science & International Affairs at Harvard's Kennedy School of Government and the John M. Olin Institute for Strategic Studies in the Government Department of Harvard's Faculty of Arts & Sciences. She has been published in the *New York Times*, *Policy Review*, the *Weekly Standard*, and *War in History*, and she has been cited in a range of media outlets including *Newsweek*.

Andrew S. Erickson is an Associate Professor in the Strategic Research Department at the U.S. Naval War College and a founding member of the department's China Maritime Studies Institute (CMSI). He is an Associate in Research at Harvard University's John King Fairbank Center for Chinese Studies (2008–). Professor Erickson is coeditor of, and a contributor to, the Naval Institute Press book series, "Studies in Chinese Maritime Development," comprising *Chinese Aerospace Power* (2011); *China, the U.S., and 21st Century Sea Power* (2010); *China Goes to Sea* (2009); *China's Energy Strategy* (2008); and *China's Future Nuclear Submarine Force* (2007). He runs two research websites, www.andrewerickson.com and www.chinasignpost.com.

James R. FitzSimonds is a Research Professor with the Center for Naval Warfare Studies at the U.S. Naval War College, where he is director of the Halsey Alfa research and analysis group. His work centers on analysis of military issues in the Asia-Pacific region, including war-fighting balances and modernization trends. Professor FitzSimonds served for twenty-seven years in the U.S. Navy as both a surface line officer and intelligence officer, retiring in 2001 with the rank of captain. His operational assignments included USS *Blakely* (FF-1072), USS *Enterprise* (CVN-65), and the USS *America* (CV-66) Battle Group, where he served as Assistant Chief of Staff for Intelligence in the Persian Gulf during Operation Desert Storm. His ashore assignments included tours with the Chief of Naval Operations Current Intelligence Division, the Navy Operational Intelligence Center Detachment (Newport), the CNO Strategic Studies Group, the Net Assessment directorate of the Office of the Secretary of Defense, and the faculty of the Naval War College. He earned

his BS from the U.S. Naval Academy in 1974 and MS from the Massachusetts Institute of Technology in 1980.

Paul S. Giarra is the President of Global Strategies & Transformation, a national defense and strategic planning consultancy. He was a Naval officer for twenty-four years and served as a naval aviator, a strategic planner, and as manager of the U.S.-Japan alliance in the Office of the Secretary of Defense. A graduate of Harvard College's last Navy ROTC class, the U.S. Naval War College, and Japan's National Institute for Defense Studies in Tokyo, he is a frequent international commentator on American and regional strategic issues in Asia and in NATO, including the strategic meeting engagement with China.

Daniel I. Gouré is a Vice President with the Lexington Institute, a nonprofit public policy research organization headquartered in Arlington, Virginia. Prior to joining the Lexington Institute, he was the Deputy Director, International Security Program, at the Center for Strategic and International Studies. He has held senior positions in both the private sector and the U.S. government. He spent two years in the U.S. government as the director of the Office of Strategic Competitiveness in the Office of the Secretary of Defense. He has taught or lectured at the Johns Hopkins University, Georgetown University, the Foreign Service Institute, the National War College, the Naval War College, the Air War College, and the Inter-American Defense College.

James R. Holmes is an associate professor of strategy at the U.S. Naval War College. Before joining the Naval War College faculty, he served on the faculty of the University of Georgia School of Public and International Affairs and as a research associate at the Institute for Foreign Policy Analysis, Cambridge, MA. His books include *Theodore Roosevelt and World Order: Police Power in International Relations*; *Chinese Naval Strategy in the 21st Century: The Turn to Mahan* (Routledge, 2007, coauthor); *Indian Naval Strategy in the 21st Century* (Routledge, 2009, coauthor); *Red Star over the Pacific: China's Rise and the Challenge to U.S. Maritime Strategy* (U.S. Naval Institute, 2011, coauthor); and *Nuclear Strategy in the Second Nuclear Age* (forthcoming, coeditor).

Bradford A. Lee holds the Philip A. Crowl Chair in Comparative Strategy at the U.S. Naval War College. A graduate of Yale College, he earned his PhD from Cambridge University and was a member of the Society of Fellows at Harvard

University, where he taught for eight years before coming to the Naval War College in 1987. At Harvard, Professor Lee was awarded the Levenson Memorial Teaching Prize as the best teacher among the assistant and associate professors. He has written extensively on strategy, diplomacy, politics, and economics in the affairs of modern states. He is now at work on a book entitled *On Winning Wars*, an analysis of how military operations translate into political results.

Thomas G. Mahnken is Jerome E. Levy Chair of Economic Geography and National Security at the U.S. Naval War College and a Visiting Scholar at the Philip Merrill Center for Strategic Studies at The Johns Hopkins University's Paul H. Nitze School of Advanced International Studies (SAIS). Professor Mahnken served as the Deputy Assistant Secretary of Defense for Policy Planning from 2006 to 2009. He is the author of *Technology and the American Way of War since 1945* (Columbia University Press, 2008) and *Uncovering Ways of War: U.S. Intelligence and Foreign Military Innovation, 1918–1941* (Cornell University Press, 2002). He is editor of *The Journal of Strategic Studies*.

Evan B. Montgomery is a Senior Fellow at the Center for Strategic and Budgetary Assessments. He has published on a wide range of topics, including nuclear proliferation, nuclear strategy, alliances, scenario-based planning, and U.S. Army modernization. He is the author of several reports in CSBA's Strategy for the Long Haul series, and his work has also appeared in *Foreign Affairs*, *International Security*, and *Security Studies*. He graduated from Villanova University with a BA in political science and sociology and received his MA and PhD in foreign affairs from the University of Virginia.

Stephen Peter Rosen is the Beton Michael Kaneb Professor of National Security and Military Affairs at Harvard University. He was the civilian assistant to the director, Net Assessment, in the Office of the Secretary of Defense; the Director of Political-Military Affairs on the staff of the National Security Council; and a professor of Strategy and Policy at the Naval War College. He participated in the President's Commission on Integrated Long Term Strategy and in the Gulf War Air Power Survey sponsored by the Secretary of the Air Force. He is the author of *Winning the Next War: Innovation and the Modern Military* (Cornell University Press, 1991), winner of the 1992 Furniss Prize; and *Societies and Military Power: India and Its Armies* (Cornell University Press, 1996).

James P. Thomas is Vice President and Director of Studies at the Center for Strategic and Budgetary Assessments, where he leads CSBA's research program focusing on the future of warfare. Earlier in his career, he served for thirteen years in a variety of policy, planning, and resource analysis posts in the Department of Defense, culminating in his dual appointment as Deputy Assistant Secretary of Defense for Resources and Plans and Acting Deputy Assistant Secretary of Defense for Strategy. He spearheaded the 2005–2006 Quadrennial Defense Review (QDR) and was the principal author of the QDR Report to Congress.

Barry D. Watts is a senior fellow at the Center for Strategic & Budgetary Assessments (CSBA). Prior to joining CSBA, he headed the Office of Program Analysis and Evaluation in the Defense Department (2001–2002). From retirement from the U.S. Air Force in 1986 until 2001, Mr. Watts was with the Northrop Grumman Analysis Center, which he directed during 1997–2001. During his Air Force career (1965–1986), Mr. Watts flew a combat tour in Southeast Asia in F-4s, taught logic and philosophy at the Air Force Academy, served twice in the Office of Net Assessment, and served in the Air Staff's Project Checkmate.
