Antonio Azuela is professor of sociology at the Universidad Nacional Autónoma de México (UNAM). Since the late 1970s, he has been engaged in research and teaching on urban and environmental law from a sociolegal perspective. His most recent book, *Visionarios y pragmáticos: Una aproximación sociológica al derecho ambiental* (Fontamara, 2006) is a sociological reconstruction of his experience as attorney general for the environment in Mexico's federal government. He is a member of the Social Research Institute (Instituto de Investigaciones Sociales) at UNAM.

Franz von Benda-Beckmann was, until his untimely death in 2013, professor emeritus and head of the Legal Pluralism Project Group at the Max Planck Institute for Social Anthropology in Halle, Germany. He was also honorary professor at the Universities of Leipzig and Halle. He authored numerous articles and book chapters on issues of property rights, social (in)security and legal pluralism in developing countries, and legal anthropological theory. Together with Keebet von Benda-Beckmann, he authored *Political and Legal Transformations of an Indonesian Polity* (Cambridge University Press 2013).

Keebet von Benda-Beckmann is associate of the Max Planck Institute for Social Anthropology in Halle, Germany. She is also honorary professor at the Universities of Leipzig and Halle. She authored numerous articles and book chapters on disputing, social (in)security, decentralization, and legal pluralism. Together with Franz von Benda-Beckmann, she authored *Political and Legal Transformations of an Indonesian Polity* (Cambridge University Press 2013).

Melinda Harm Benson is an assistant professor in the Department of Geography and Environmental Studies at the University of New Mexico. She is the author of "Regional Initiatives: Scaling the Climate Response and Responding to Conceptions of Scale," published in 2010 by *Annals of the Association of American Geographers*, and "Mining Sacred Space: Law's Enactment of Competing Ontologies in

the American West,” published in 2012 by *Environment and Planning A*. Prior to her academic life, she worked as an attorney representing environmental organizations in the intermountain West.

Nicholas Blomley is professor of geography at Simon Fraser University. He has a long-standing interest in legal geography (particularly in relation to property). He is the author of *Law, Space and the Geographies of Power* (Guilford 1994), *Unsettling the City* (Routledge 2004), and *Rights of Passage: Sidewalks and the Regulation of Public Flow* (Routledge 2012). He also coedited *The Legal Geographies Reader* (Blackwell 2001).

Irus Braverman is professor of law and adjunct professor of geography at the State University of New York (SUNY) Buffalo. Her main interests lie in the interdisciplinary study of law, geography, and anthropology. She is author of *House Demolitions in East Jerusalem: “Illegality” and Resistance* (2004), *Planted Flags: Trees, Land, and Law in Israel/Palestine* (Cambridge University Press 2009), and *Zooland: The Institution of Captivity* (Stanford University Press 2012).

David Delaney teaches in the Department of Law, Jurisprudence and Social Thought at Amherst College. He is the author of *Race, Place and the Law* (University of Texas Press 1998), *Law and Nature* (Cambridge University Press 2003), *Territory: A Short Introduction* (Blackwell 2005), and *The Spatial, the Legal and the Pragmatics of World-Making: Nomospheric Investigations* (Routledge/GlassHouse 2010), as well as numerous articles on the theme of legal geography. He also coedited *The Legal Geographies Reader* (Blackwell 2001).

Alexandre (Sandy) Kedar is senior lecturer at University of Haifa’s law school. His principal research focus is on legal geography, legal history, law and society, and land regimes in settler societies and in Israel. He is coeditor of *The History of Law in a Multi-Cultural Society: Israel 1917–1967* (2002), as well as numerous articles in English and Hebrew.

Rodrigo Meneses-Reyes is professor researcher in the Department of Legal Studies of the Center for Research and Teaching in Economics (CIDE) in Mexico City. He is the author of *Public Legalities: Law, Street Vendors and the Historical Downtown in Mexico City (1930–2010)* (CIDE and Universidad Nacional Autónoma de México 2012).

Lisa R. Pruitt is professor of law at the University of California, Davis, School of Law. She has written extensively about law and rural livelihoods, studying how rural spatiality inflects dimensions of gender, race, and ethnicity. Her publications include “Toward a Feminist Theory of the Rural,” in *Utah Law Review* (2007);

“Rural Rhetoric,” in *Connecticut Law Review* (2006); and “Justice Deserts: Spatial Inequality and Local Funding of Indigent Defense,” in *Arizona Law Review* (2010).

He has published articles and reviews in *Urban Geography*, *Social and Legal Studies* (coauthored with Joel Bakan), *Political Geography*, and *Dialogues in Human Geography*. His research interests span legal, political, and economic geography, and his PhD research focuses on the legal geographies and political economy of the Canadian state. He has been a practicing lawyer since 1998, working primarily as criminal appellate counsel providing legal services to low-income people.

Mariana Valverde is professor of criminology at the Centre for Criminology and Sociolegal Studies at the University of Toronto. She has published six sole-authored books (two of them popular), six coedited anthologies, and more than forty-five refereed scholarly articles. Her most recent book, *Everyday Law on the Street*, received the Law and Society Association’s Herbert Jacobs Prize for best book of 2012 in sociolegal studies, which was also awarded to her 1998 book *Diseases of the Will: Alcohol and the Dilemmas of Freedom*.
