JOHN ARQUILLA is Professor of Defense Analysis at the U.S. Naval Postgraduate School, and author of several books and many articles on military and security affairs. He is best known for his collaborative RAND studies with David Ronfeldt, most notably *In Athena's Camp* (1997) and *Networks & Netwars: The Future of Terror, Crime, and Militancy* (2001).

CHRIS C. DEMCHAK is Associate Professor at the University of Arizona. Her research focuses on how networks and associated complex systems affect the availability of technology and other aspects of the information revolution to various organizations around the globe. Her publications include a book and several articles comparing military modernizations. Demchak is a U.S. Army Reserve officer whose regional expertise includes Europe, Africa, and the Middle East. She is currently working on a comparative study of future paths of military change given new knowledge management tools, widening global integration (including effects of the internet), and growing U.S. involvement in coordinating antiterror operations.

MICHAEL J. EISENSTADT is a senior fellow at the Washington Institute for Near East Policy. A specialist on Arab-Israeli and Persian Gulf security affairs, his publications include several articles and monographs on the armed forces of Iraq, Iran, Syria, and Israel, and regional arms control. He has worked as a military analyst with the U.S. Army, where he is a reserve officer. He has served in Turkey and Iraq as part of Operation Provide Comfort. He holds an M.A. in Arab Studies from Georgetown University and has traveled widely in the Middle East.

LESLIE C. ELIASON is Associate Professor and Program Head at the Monterey Institute of International Studies. She is the coeditor of *Forward to the Past: Continuity and Change in Political Development in Hungary, Austria, and the Czech and Slovak Republics* (Aarhus University Press, 1997) and *Fascism, Liberalism and*

Social Democracy in Central Europe: Past and Present (Aarhus University Press, 2002). Her research focuses on organizational and bureaucratic change, including administrative capacity building in transitional states. She has also published several articles dealing with the process of policy learning and diffusion of innovation in the public sector in European welfare states. She received her Ph.D. from Stanford University and taught at the University of Washington from 1988 until 1997.

EMILY O. GOLDMAN is Associate Professor of Political Science at the University of California, Davis, and Codirector of the Joint Center for International and Security Studies. She is author of *Sunken Treaties: Naval Arms Control between the War* (Penn State Press, 1994) and articles on U.S. strategic, military, and arms control policy; strategic adaptation in peacetime; military innovation; organizational change; and defense resource allocation. Her current research focuses on the causes and consequences of military transformation in the information age. She has directed projects on the role of information in past revolutions in military affairs, and on the diffusion of the current revolution in military affairs in the Asia-Pacific region. She holds a Ph.D. from Stanford University and was a Secretary of the Navy Senior Research Fellow at the U.S. Naval War College.

GEOFFREY L. HERRERA is Assistant Professor of Political Science at Temple University. He holds a Ph.D. in Politics from Princeton University and has taught at The Johns Hopkins University, Swarthmore College, and the University of Pennsylvania. His scholarly work has appeared in the journal *Review of International Studies*.

TIMOTHY D. HOYT is Associate Professor of Strategy at the U.S. Naval War College. He received a Ph.D. in International Relations and Strategic Studies from The Johns Hopkins University in 1997. He has lectured, taught, and consulted for Georgetown University, the University of Maryland, the Naval War College, the Army War College, the National War College, the National Security Agency, and the Department of Defense. His research interests include technology and international security, strategy, and national security policies in the developing world. His recent publications include "Pakistani Nuclear Doctrine and the Dangers of Strategic Myopia," *Asian Survey* (Nov.–Dec. 2001), "Indian Views of the Emerging RMA," coauthored with Dr. Thomas G. Mahnken, *National Security Studies Quarterly* (summer 2000), and "Indian Military Modernization, 1990–2000," *Joint Force Quarterly* (summer 2000). Dr. Hoyt is the author of *Military Industry and Regional Power: Israel, Iraq and India* (forthcoming, 2003, Frank Cass).

CHRISTOPHER JONES is Associate Professor at the Henry M. Jackson School of International Studies at the University of Washington. He is also Director of the

UW's Institute for Global and Regional Security Studies. During 1999–2000, he was a fellow at the Woodrow Wilson International Center for Scholars. Among his most recent publications are “The Logic of NATO Enlargement: De-Nationalization, Democratization, Defense of Human Rights and De-Nuclearization,” in Oles Smolensky, ed., *The Lost Equilibrium: International Relations in the Post-Soviet Era* (Lehigh University Press, 2001); “The Case of the Disappearing Army,” a review article for *Contemporary Security Policy* (June 2001), and “Limits to Europe,” a review article in *International Politics* (Dec. 2000).

JOHN A. LYNN is Professor of History at the University of Illinois and Adjunct Professor at the Ohio State University. He concentrates on military practice and warfare in early modern Europe, on eras of military transition, and on war and culture. His most recent works include *Giant of the Grand Siècle: The French Army, 1610–1715* (Cambridge, 1997), *The Wars of Louis XIV* (Longman, 1999), and *The French Wars, 1667–1714: The Sun King at War* (Osprey, 2002). He is currently revising his manuscript *Battle: A History of Combat and Culture*, which will appear in 2003.

THOMAS G. MAHNKEN is Professor of Strategy at the U.S. Naval War College. He is a graduate of the University of Southern California and holds a Ph.D. from the Paul H. Nitze School of Advanced International Studies of The Johns Hopkins University. He previously served in the Pentagon's Office of Net Assessment and as a member of the Secretary of the Air Force's Gulf War Air Power Survey. He is the author of *Uncovering Ways of War: U.S. Intelligence and Foreign Military Innovation, 1918–1941* (Cornell University Press, 2002).

KENNETH M. POLLACK is currently Director of Research and Senior Fellow at the Saban Center for Middle East Policy of the Brookings Institution. He was previously Director of National Security Studies at the Council on Foreign Relations. He has served twice as Director for Near East and South Asian Affairs at the National Security Council, in 1995–96 and 1999–2001. From 1988 until 1995 he was a Persian Gulf Military Analyst at the Central Intelligence Agency, where he wrote a classified history of Iraqi strategy and operations during the Persian Gulf War. Dr. Pollack has also been a Senior Research Professor at the Institute for National Strategic Studies of the National Defense University, and a Research Fellow at the Washington Institute for Near East Policy. He is the author of *Arabs at War: Military Effectiveness, 1948–1991* (University of Nebraska Press, 2002), and *The Threatening Storm: The Case for Invading Iraq* (Random House, 2002), in addition to numerous journal articles on Middle Eastern military and security issues. Dr. Pollack received his Ph.D. from the Massachusetts Institute of Technology.

WILLIAM C. POTTER is Institute Professor and Director of the Center for Nonproliferation Studies and the Center for Russian and Eurasian Studies at the Monterey Institute of International Studies. The author or editor of thirteen books dealing with nonproliferation and national security issues, his present research focuses on nuclear nonproliferation issues involving the post-Soviet states. A member of the Council on Foreign Relations and the International Institute for Strategic Studies, Dr. Potter serves on the UN Secretary-General's Advisory Board on Disarmament Matters, the Board of Trustees of the UN Institute for Disarmament Research, and the International Advisory Board of the Center for Policy Studies in Moscow. He was an advisor to the delegation of Kyrgyzstan to the 1995 NPT Review and Extension Conference and to the 1997, 1998, 1999, and 2002 sessions of the NPT Preparatory Committee, as well as to the 2000 NPT Review Conference.

ANDREW L. ROSS is Professor of Strategic Studies and Director of Studies in the Strategic Research Department of the U.S. Naval War College's Center for Naval Warfare Studies. He is also Director of the College's project on "Military Transformation and the Defense Industry after Next." His work on grand strategy, defense planning, regional security, weapons proliferation, the international arms market, defense industrialization, and security and development has appeared in numerous journals and books. Professor Ross is the editor of *The Political Economy of Defense: Issues and Perspectives* (Greenwood Press, 1991) and coeditor of three editions of *Strategy and Force Planning* (Naval War College Press, 1995; 2d ed., 1997; 3d ed., 2000). He has held research fellowships at Cornell, Princeton, Harvard, the University of Illinois, and the Naval War College, and previously taught at the University of Illinois and the University of Kentucky.

THOMAS-DURELL YOUNG is European Program Manager of the Center for Civil-Military Relations at the U.S. Naval Postgraduate School in Monterey, California, where he is responsible for developing and managing technical assistance projects throughout Europe. Previously he was a Research Professor at the Strategic Studies Institute of the U.S. Army War College. Dr Young received his Ph.D. and Certificat d'études supérieures from the Institut universitaire de Hautes Etudes internationales, Université de Genève, and is a 1990 graduate of the U.S. Army War College. His latest book, coauthored with the late John Borawski, *NATO after 2000: The Future of the Euro-Atlantic Alliance*, was published by Praeger in 2001. In 1999 he was the inaugural Eisenhower Fellow at the Royal Netherlands Military Academy in Breda. He is coeditor of *Small Wars and Insurgencies* and serves on the editorial board of *Defense and Security Analysis*. Dr. Young is also a consultant for the RAND Corporation.
