This book arose as the unexpected product of the efforts of numerous Chinese women to explain to me the changes in their lives during the reform era, as well as the changes in the role of the official women's movement in China from the late 1980s. I have attempted to listen closely to their voices, but I expect they will find my views remain some distance from their own. I hope, nevertheless, that they will read in these pages faithful accounts of their resourcefulness in working under challenging circumstances to improve the lives of women in rural China.

The fieldwork reported here was conducted from 1988 to 1995, with generous support from the Social Sciences and Humanities Research Council of Canada through a SSHRCC-Chinese Academy of Social Sciences Exchange Grant, 1987-88; a SSHRCC Canada Research Fellowship, 1987-92; and SSHRCC Research Grants, 1990-91 and 1992-96. Within China, the research was made possible by staff of the Shandong Academy of Social Sciences, the China Shandong International Culture Exchange Centre, the Shandong Women's Federation, the Qingdao Women's Federation, the Jining Women's Federation, the Dezhou Women's Federation, the Lingxian Women's Federation, and various levels of government in Shandong province. I am especially indebted to the women of the rural community of Huaili and to all those who accompanied me and made my visits to Huaili possible. The research was further enriched by numerous members of women's organizations in Jinan, Qingdao, Jining, and Lingxian, and by scholars in women's studies in various locations in Shandong.

Within Canada, writing began while I was a Visiting Scholar at the Centre for Research in Women's Studies and Gender Relations (which also granted a research allowance) and at Green College, University of British Columbia. I benefited from office space and a collegial environment in the Department of Anthropology and Sociology, University of
