Jenna Bednar is an assistant professor in the Department of Political Science at the University of Michigan and is an associated faculty member with the Olin Center for Law and Economics at the University of Michigan Law School. Her work has been published in the *Southern California Law Review* and the *International Review of Law and Economics*. She is currently writing a book about the relationship between federalism and democratic theory.

Keith L. Dougherty is an assistant professor of political science at the University of Georgia, with research interests in American political development, federalism, and social choice. His previous publications on the American Founding include: *Collective Action under the Articles of Confederation* (Cambridge University Press, 2001); "Defending the Articles of Confederation," *Public Choice* (2001); "Suppressing Shays' Rebellion" (with Michael Cain), *Journal of Theoretical Politics* (1999); as well as several chapters in edited volumes.

John Ferejohn is the Carolyn S. G. Munro Professor of Political Science and senior fellow of the Hoover Institution at Stanford University. He is coauthor or coeditor of *Pork Barrel Politics*; *The Personal Vote*; *Federalism: Can the States Be Trusted*; and *Constitutional Culture and Democratic Rule*. He has written variously about American politics and political institutions, comparative politics, political theory and mathematical models in politics. He is currently working on issues of comparative constitutional law and jurisprudence as well as on topics of American politics.

Samuel Kernell is a professor of political science at the University of California, San Diego. He is the author of numerous books and articles, including *Going Public: New Strategies of Presidential Leadership* 3d ed. (CQ Press, 1997); and (with Gary C. Jacobson) *Strategy and Choice in Congressional Elections* (Yale, 1983) as well as *The Logic of American Politics* (CQ Press, 2000). His current research concerns the institutional determinants of elections and political career development during the nineteenth and early twentieth centuries.

D. Roderick Kiewiet is Professor of Political Science at the California Institute of Technology. He is the author of *Macroeconomics and Micropolitics: The Electoral Ef-*

fects of Economic Issues (Chicago, 1983); coauthor of *The Logic of Delegation: Congressional Parties and the Appropriations Process* (Chicago, 1991); and *Stealing the Initiative: How State Government Responds to Direct Democracy* (Prentice-Hall, 2000). His recent journal articles and continuing research interests center on American policy and politics, Russian politics, and the history of the early American republic.

Iain McLean is Professor of Politics, Oxford University, and a fellow of Nuffield College. Recent books and papers include *Rational Choice & British Politics: An Analysis of Rhetoric and Manipulation from Peel to Blair* (Oxford University Press, 2001); *International Trade and Political Institutions* (with three coauthors) (Elgar, 2001); and “William H. Riker and the Invention of Heresthetics,” *British Journal of Political Science* (July 2002). Current research interests include: heresthetics in political history and public policy.

David Brian Robertson is Professor of Political Science and a fellow in the Public Policy Research Center, University of Missouri—St. Louis. He is the author of *The Development of American Public Policy: The Structure of Policy Restraint* (with Dennis R. Judd); and *Capital, Labor, and State: The Battle for American Labor Markets from the Civil War to the New Deal*; as well as numerous articles and chapters on American political development. He currently is working on two books: *Constituting American Politics: The Framers and America’s Political Destiny*; and *Capital, Environment, and State*.

Norman Schofield is the William Taussig Professor of Political Economy at Washington University. His numerous articles and books include *Social Choice and Democracy* (Springer 1985); and *Multiparty Government* (with Michael Laver) (Oxford University Press, 1990, and University of Michigan Press, 1995). He has recently been engaged in attempts to apply these theories to the origins of American political economy.

Randall Strahan is Associate Professor of Political Science at Emory University. He is author of “The Clay Speakership Revisited,” *Polity* 32 (summer 2000): 561–93 (with Vincent Moscardelli, Moshe Haspel, and Richard Wike); and “Leadership and Institutional Change in the Nineteenth-Century House,” in *Party, Process, and Political Change: New Perspectives on the History of Congress*, ed. David W. Brady and Mathew D. McCubbins (Stanford, 2002). He is currently completing a study of leadership and institutional development in the U.S. House from the early nineteenth century to the present.

Rick K. Wilson is Professor of Political Science at Rice University. His interests focus on institutional analysis and design, decision-making, and political history. Among his publications, *Congressional Dynamics: Structure, Coordination and Choice in the First American Congress, 1774–1789* (with Calvin Jillson) first identified the

collective action problems endemic in America's first Constitution. His current research has taken him to Siberia, where he has conducted experiments relating to trust, fairness, and reciprocity among different ethnic groups.

Daniel Wirls is Associate Professor of Politics at the University of California, Santa Cruz. He is the author of *Buildup: The Politics of Defense in the Reagan Era*; articles and chapters on Congress, American political history, and political behavior; and coauthor of *The Invention of the United States Senate* (Johns Hopkins University Press, forthcoming 2003).
