WENDY BRACEWELL is senior lecturer in history and director of the Centre for South-East European Studies at the School of Slavonic and East European Studies, University College London. She was adopted as a Vucinich niece as an undergraduate at Stanford after showing an interest in Balkan languages, and was subsequently enticed into pursuing research on frontier society and border warfare in the graduate program. Most subsequent writing, whether on sixteenth-century border raiders (*The Uskoks of Senj: Piracy, Brigandage and Holy War in the Sixteenth-Century Adriatic* [1992]), on gender and nationalism, or on definitions of "South-East Europe," reveals the influence of the Vucinich School.

HOLLY CASE is a Ph.D. candidate in East European history at Stanford. She is at work on her dissertation on ethnic relations in wartime Cluj.

DUŠAN J. DJORDJEVICH is a Ph.D. candidate in history at Stanford, completing his dissertation on the national question in late interwar Yugoslavia. He is co-editor of *Political and Ideological Confrontations in Twentieth-Century Europe* (1996).

THOMAS A. EMMERT (Stanford Ph.D., 1973, under Wayne S. Vucinich) is professor of history at Gustavus Adolphus College in St. Peter, Minnesota, where he teaches courses on Russia, the Ottoman Empire, and the Balkans. He is the author of *Serbian Golgotha: Kosovo, 1389*, editor with W. S. Vucinich of *Kosovo: Legacy of a Medieval Battle*, and is completing a one-volume *History of Serbia* for the Studies of Nationalities series at Hoover Institution Press.

JOHN V. A. FINE is professor of history at the University of Michigan, Ann Arbor. He teaches and writes on Byzantium and the modern and medieval Balkans. Professor Fine is the author of *The Bosnian Church; The Early Medieval Balkans; The Late Medieval Balkans*; and (with Robert J. Donia) *Bosnia-Hercegovina: A Tradition Betrayed*.

CHARLES JELAVICH is professor of history, emeritus, at Indiana University. He received his AB (1944), MA (1947), and Ph.D. (1949) from the University of California at Berkeley. In 1986–87, Professor Jelavich was president of the American Association for the Advancement of Slavic Studies. He is author of *Tsarist Russia and Balkan Nationalism*; *South Slav Nationalisms: Textbooks and Yugoslav Union before 1914*; co-author of *Russia in the East, 1876–1880*; *The Education of a Russian Statesman: Memoirs of Nicholas Karlovich Giers*; *The Establishment of the Balkan National States, 1804–1920*; editor of *Language and Area Studies: East Central and Southeastern Europe*; and co-editor of *The Balkans in Transition*.

BARIŠA KREKIĆ is professor of history, emeritus, at the University of California at Los Angeles. He received his Ph.D. at the Serbian Academy of Arts and Sciences in 1954. Professor Krekić conducted post-doctoral studies at the Sorbonne in Paris, 1957–58, and has taught at Belgrade and Novi Sad Universities in Yugoslavia, at Central European University in Budapest, at Indiana and Stanford Universities, and, since 1970, at the University of California, Los Angeles. He is the author of five books and numerous articles published in the United States and Europe. His main research topic is the history of late medieval and Renaissance Dubrovnik (Ragusa) and Venice.

NORMAN M. NAIMARK is Robert and Florence McDonnell Professor of East European Studies at Stanford. His latest book is *Fires of Hatred: Ethnic Cleansing in Twentieth-Century Europe* (Harvard University Press, 2001).

ANDREW ROSSOS is professor of history at the University of Toronto. Over the years his research has ranged from Russian-Balkan relations to Czech historiography to the Macedonian question. His studies on Macedonian history have appeared in *Slavonic and East European Review* (1991), *Slavic Review* (1994), *National Character and National Ideology in Interwar Eastern Europe* (I. Banac and K. Verdery, eds., 1995), *Journal of Modern History* (1997), and, most recently, *East European Politics and Societies* (2000). He is now preparing a volume, *Macedonia and the Macedonians: A History*, for the Studies of Nationalities series published by the Hoover Institution Press.

GALE STOKES is Mary Gibbs Jones Professor of History and interim dean of humanities at Rice University. He is the author of *The Walls Came Tumbling Down: The Collapse of Communism in Eastern Europe* (winner of the Vucinich Prize for the best book on Eastern Europe and

Eurasia for 1993); *From Stalinism to Pluralism: A Documentary History of Eastern Europe since 1945*; and *Three Eras of Historical Change in Eastern Europe*. Professor Stokes has also written monographs on Serbian history and recently published a Western Civilization textbook. He has won several teaching awards at Rice and has appeared in national forums such as the *McNeil/Lehrer News Hour*, National Public Radio, the *Washington Post*, and CNN.

ARNOLD SUPPAN is professor of East European history at the University of Vienna and president of the Austrian Institute of East and South-east European Studies. Born in 1945 in Carinthia, Professor Suppan received his Ph.D. from the University of Vienna in 1970, where he has taught since 1971. He has also been a visiting professor at the universities of Klagenfurt, Leiden, and Fribourg and at Stanford. His main publications are *Innere Front: Militärassistentz, Widerstand und Umsturz in der Donaumonarchie, 1918* (1974); *Die österreichischen Volksgruppen* (1983); *Ostmitteleuropa am Wendepunkt, 1938* (1988); *Jugoslawien und Österreich, 1918–1938* (1996); and *Zwischen Adria und Karawanken* (1998).

WAYNE S. VUCINICH is Robert and Florence McDonnell Professor of East European Studies, emeritus, at Stanford University. Among his books are *Serbia Between East and West*; *The Ottoman Empire*; and, most recently, *Ivo Andrić Revisited* (editor). He has served as president of the American Association for the Advancement of Slavic Studies and is at present general editor of the Studies of Nationalities series published by Hoover Institution Press.

LARRY WOLFF is professor of history at Boston College. He received his AB from Harvard in 1979 and his Ph.D. from Stanford in 1984. He is the author of *The Vatican and Poland in the Age of the Partitions*; *Postcards from the End of the World: Child Abuse in Freud's Vienna*; *Inventing Eastern Europe: The Map of Civilization on the Mind of the Enlightenment*; and *Venice and the Slavs: The Discovery of Dalmatia in the Age of Enlightenment*.
