R. Lanier Anderson is an Associate Professor in the Department of Philosophy at Stanford University and co-director of Stanford's Literature and Philosophy Initiative. He has published numerous articles on Kant, Nietzsche, neo-Kantianism, and nineteenth-century philosophy.

Dan Edelstein is an Assistant Professor of French at Stanford University. His first book, *The Terror of Natural Right*, which has been accepted for publication by the University of Chicago Press, concerns republicanism and natural right theory in eighteenth-century France. He is currently working on a project concerning the "Super-Enlightenment."

Hans Ulrich Gumbrecht is the Albert Guérard Professor in Literature in the Departments of French and Italian and Comparative Literature at Stanford University. He is a fellow of the American Academy of Arts and Sciences. He is the author of over a thousand articles and several books, including *In 1926: Living at the Edge of Time* (Harvard, 1997), *In Praise of Athletic Beauty* (Harvard, 2006), *Production of Presence: What Meaning Cannot Convey* (Stanford, 2004), and *The Powers of Philology: Dynamics of Textual Scholarship* (University of Illinois, 2003).

Robert Harrison is the Rosina Pierotti Professor in Italian Literature in the Department of French and Italian at Stanford University. He is a fellow of the American Academy of Arts and Sciences. He is the author of *The Dominion of the Dead* (Chicago, 2003), *Forests: The Shadow of Civilization* (Chicago, 1992), *The Body of Beatrice* (Johns Hopkins, 1988), and *Gardens: An Essay on the Human Condition* (Chicago, 2008).

Joshua Landy is Associate Professor in the Department of French and Italian at Stanford University, and co-director of Stanford's Initiative in Philosophy and Literature. He is the author of *Philosophy as Fiction: Self, Deception, and Knowledge in Proust* (Oxford, 2004) and the editor, with Claude Bremond and Thomas Pavel, of *Thematics: New Approaches* (SUNY, 1995). He is currently working on a second book, *Formative Fictions: Literary Structure and the Life Well Lived*.

Andrea Nightingale is a Professor in the Departments of Classics and Comparative Literature at Stanford University. She is the author of *Genres in Dialogue: Plato and the Construct of Philosophy* (Cambridge, 1996) and *Spectacles of Truth in Classical Greek Philosophy: Theoria in its Cultural Context* (Cambridge, 2004). She is currently researching the philosophy and literature of ecology in the modern and postmodern periods.

Nicholas Paige is an Associate Professor of French at the University of California, Berkeley. Author of *Being Interior: Autobiography and the Contradictions of Modernity in Seventeenth-Century France* (Penn, 2001), he is currently completing *Fiction before Fiction*, a study of modes of fictional reference in the French novel from seventeenth-century romance to nineteenth-century realism.

Michael Saler is a Professor in the Department of History at the University of California, Davis. His research interests include modern European intellectual and cultural history and modern British history. He is the author of *The Avant-Garde in Interwar England: "Medieval Modernism" and the London Underground* (Oxford, 1999), and is currently working on a history of the rational enchantments of Imaginary Worlds during the late nineteenth and twentieth centuries.

Michel Serres is a member of the Académie Française, and a Professor of French in the Department of French and Italian at Stanford University. He is the author of numerous books, including most recently *Le mal propre: Polluer pour s'approprier* (Paris: Pommier, 2008); *Carpaccio: Les esclaves libérés* (Paris: Pommier, 2007); *L'art des ponts: homo pontifex* (Paris: Pommier, 2006).

Linda Simon is a Professor of English at Skidmore College. Her books include *Genuine Reality: A Life of William James* (Harcourt, 1997), *Dark*

*Light: Electricity and Anxiety from the Telegraph to the X-Ray* (Harcourt, 2004), and *The Critical Reception of Henry James: Creating a Master* (Camden House, 2007). She is General Editor of *William James Studies* and a past president of the William James Society.

Daniel Jiro Tanaka has taught at Vassar College and Clark University. He received his Ph.D. in German from Princeton, with a dissertation titled *Forms of Disenchantment: Kant and Neo-Kantianism in the Early Work of Walter Benjamin*. He is currently working on a book-length study of disenchantment in modern German thought.

Maiken Umbach is a Senior Lecturer in Modern European History at the University of Manchester. She is the joint editor of *German History*, the journal of the German History Society, and co-director of the Centre for Research on the Cultural Forms of Modern European Politics. She is the author of *Federalism and Enlightenment in Germany, 1740–1806* (Hambledon, 2000); she is the editor of *German Federalism: Past, Present, Future* (Macmillan/Palgrave, 2002) and co-editor, with Bernd Hüppauf, of *Vernacular Modernism: Heimat, Globalization and the Built Environment* (Stanford, 2005). She is currently working on her second book, *German Cities and the Genesis of Modernism, 1890–1930*.

Robin Walz is an Associate Professor of History and Chair of the Department of Social Science at the University of Alaska Southeast. His research focuses on French popular culture and fiction and French and European intellectual history. He is the author of *Pulp Surrealism: Insolent Popular Culture in Twentieth-Century France* (U. California, 2000). He is currently working on his second book, *Detectives, Avengers, and Elegant Criminals: Popular Characters and French Identity, 1815–1950*.
