Shahrough Akhavi is a professor in the Department of Political Science at the University of South Carolina in Columbia, South Carolina. He received his B.A. from Brown University (1962), M.A. from Harvard University (1964), and Ph.D. from Columbia University (1969). Akhavi has published *Religion and Politics in Contemporary Iran* (Albany: State University of New York Press, 1980) and numerous articles in academic journals. He conducted field research in the sociology of Islam in Iran and Egypt under grants from the Ford Foundation (1975), the National Endowment for the Humanities (1980–81), the Fulbright Senior Scholar Program (1991), and the Social Science Research Council (1998). He has served the profession in various capacities, such as president of the Society for Iranian Studies (2002–3), chairman of the Nominating Committee of the Society for Iranian Studies (1997–98), and a member of numerous nominating and program committees of the Middle East Studies Association (MESA) and the Biennial Conference of Iranian Studies. He is the editor of two book series for the State University of New York Press and for Routledge Publishers and has participated as section editor and senior consulting editor in the multivolume *Oxford Encyclopedia of the Modern Islamic World* (1995) and the forthcoming *Oxford Encyclopedia of Islam*.

Abbas Amanat is professor of history at Yale University. Among his publications are *Resurrection and Renewal: The Making of the Babi Movement in Iran, 1844–1850* (Ithaca, NY: Cornell University Press, 1989); *Pivot of the Universe: Nasir al-Din Shah Qajar and the Iranian Monarchy, 1831–1896* (Berkeley: University of California Press, 1997); “The Resurgence of Apocalyptic in Modern

Islam,” in *The Encyclopedia of Apocalypticism* (New York: Continuum, 1999); and “Empowered Through Violence: The Reinventing of Islamic Extremism,” in *The Age of Terror*, ed. Strobe Talbott and Nayan Chanda (New York: Basic Books, 2001). He coedited *Imaging the End: Visions of Apocalypse from the Ancient Middle East to Modern America* (London and New York: I. B. Tauris, 2002). His forthcoming book, *In Search of Modern Iran: Authority, Identity, and Nationhood*, will be published by Yale University Press.

Saïd Amir Arjomand (Ph.D., University of Chicago, 1980) is Distinguished Service Professor of Sociology at the State University of New York at Stony Brook. He was the inaugural Crane Fellow and visiting professor of public affairs at the Woodrow Wilson School of Princeton University (2004–5) and is visiting fellow at its Department of Near Eastern Studies (2006–8). He was the editor of *International Sociology* from 1998 to 2003 and is the founder and president (1996–2002, 2006–10) of the Association for the Study of Persianate Societies. He is the author of some eighty articles and book chapters, including “Constitutions and the Struggle for Political Order: A Study in the Modernization of Political Traditions,” *European Journal of Sociology* 33 (1992), which won the American Sociological Association’s award in 1993 for the Best Essay in Comparative and Historical Sociology. His books include *The Turban for the Crown: The Islamic Revolution in Iran* (New York: Oxford University Press, 1988) and, coedited with Edward A. Tiryakian, *Rethinking Civilizational Analysis* (London: Sage Publications, 2004). Arjomand is a Carnegie Scholar for 2006–8 and currently working on a constitutional history of the Islamic Middle East.

Noah Feldman is the Cecelia Goetz Professor of Law at New York University School of Law. He specializes in constitutional studies, with particular emphasis on the relationship between law and religion, constitutional design, and the history of legal theory. Feldman received his A.B. summa cum laude in Near Eastern Languages and Civilizations from Harvard University and his D.Phil. in Islamic thought from Oxford University. He received his J.D. from Yale Law School. He was a junior fellow of the Society of Fellows at Harvard University. Feldman is the author of *Divided by God: America’s Church-State Problem and What We Should Do About It* (New York: Farrar, Straus & Giroux, 2005); *What We Owe Iraq: War and the Ethics of Nation Building* (Princeton: Princeton University Press, 2004); and *After Jihad: America and the Struggle for Islamic Democracy* (New York: Farrar, Straus & Giroux, 2003). He is a contributing writer for

the *New York Times Magazine* and an adjunct senior fellow at the Council on Foreign Relations.

Frank Griffel is associate professor of Islamic studies at Yale University. He studied philosophy, Arabic literature, and Islamic studies at Göttingen and Damascus universities and at the Free University of Berlin. He received his Ph.D. in 1999 in Berlin. After working as a research fellow at the Orient Institute of the Deutsche Morgenländische Gesellschaft in Beirut (Lebanon), he came to Yale in 2000. In 2003–4 he was Andrew Mellon Fellow at the Institute for Advanced Study in Princeton. He has published in the fields of Islamic law, Muslim theology, and Muslim intellectual history. In his book *Apostasie und Toleranz im Islam* [Apostasy and Tolerance in Islam] (Leiden: Brill, 2000) he analyzes the development of the judgment of apostasy up to the twelfth century. More recent publications include articles on al-Ghazālī (d. 1111), Ibn Tūmart (d. 1130), Fakhr al-Dīn al-Rāzī (d. 1210), and other Muslim thinkers in the *Journal of Islamic Studies*, the *Journal of the American Oriental Society*, *Arabic Sciences and Philosophy*, and a number of collective volumes. Griffel is a Carnegie Scholar for 2007–9. His forthcoming book, *The Philosophical Theology of al-Ghazālī: An Introduction to the Study of His Life and Thought*, will be published by Oxford University Press.

David L. Johnston worked as a pastor and a teacher in Algeria, Egypt, and the Palestinian West Bank between 1978 and 1996. He subsequently completed a Ph.D. in Islamic studies at Fuller Theological Seminary in Pasadena, California, and spent five years as a postdoctoral fellow, part-time lecturer, and research associate at the Religious Studies Department of Yale University. Johnston is currently a visiting scholar at the Department of Near Eastern Languages and Civilizations of the University of Pennsylvania. His articles have appeared in *Islamic Law and Society*, *Islamochristiana*, and *Maghreb Review*. He contributed to *Encyclopaedia of the Qur'an* and *Encyclopedia of Islam and the Muslim World*. His book *Earth, Empire and Sacred Text: Muslims and Christians as Trustees of Creation* will be published in 2007 by Equinox in London.

Gudrun Krämer is professor of Islamic studies at the Free University of Berlin and a member of the Berlin-Brandenburg Academy of Sciences. She studied history, political science, English literature, and Islamic studies at Heidelberg, Bonn, and Sussex universities and obtained a Ph.D. in Islamic studies from

Hamburg University in 1982. In 1982–94 she was senior research fellow at the Stiftung Wissenschaft und Politik at Ebenhausen, Germany. She was appointed professor of Islamic studies at Bonn University in 1994 and moved to the Free University of Berlin in 1996. She has been a visiting scholar at the Centre d'Études et de Documentation Économique, Juridique et Sociale (CEDEJ) in Cairo; the School of Advanced International Studies of Johns Hopkins University, Bologna Center; the Institut d'Études Politiques (Sciences Po) and the École des Hautes Etudes en Sciences Sociales, both in Paris; the Islamic University in Jakarta, Indonesia; and the Max Weber Kolleg in Erfurt, Germany. She is a member of the academic boards of the Goethe Institut, the German Ministry of Economic Cooperation, and the French Ministère d'Affaires Étrangères, Pole Proche-Orient. She has published extensively on the modern history of the Arab world, Islamist movements, and Islamic political thought and is one of the executive editors of the forthcoming third edition of *The Encyclopaedia of Islam*.

Roy P. Mottahedeh is the Gurney Professor of History at Harvard University. He was educated at Harvard (A.B., 1960; Ph.D., 1970) and at Cambridge University (B.A., 1962) and has received numerous academic awards, including a Guggenheim Fellowship and a MacArthur Prize Fellowship. His major work is on the premodern social and intellectual history of the Islamic Middle East. His publications include *Loyalty and Leadership in an Early Islamic Society* (Princeton: Princeton University Press, 1980), *The Mantle of the Prophet: Religion and Politics in Iran* (New York: Simon and Schuster, 1985), and his translation of Muḥammad Bāqir al-Ṣadr, *Lessons in Islamic Jurisprudence* (Oxford: Oneworld, 2003). He is presently working on a history of the Iraqi Shiite 'ulama' in the period 1958–2003.

Felicitas Opwis is assistant professor of Arabic and Islamic studies at Georgetown University in Washington, D.C. Earlier she worked as an adjunct professor of religion at Wake Forest University and a visiting lecturer on Islamic law at Yale School of Law. She graduated with an M.A. in Islamic studies from the University of Freiburg, Germany, and received her Ph.D. in Arabic and Islamic studies in 2001 from Yale University. Her main research interests are the development of legal theory in its historical context and the relationship between religious law and political authority. Recent publications include an article on the development of the concept of *maṣlaḥa* in the classical and contemporary

period in *Islamic Law and Society* and a chapter on Islamic law in the modern world in the collective volume *An Islamic Reformation?* edited by M. Browsers and C. Kurzman (Lanham, MD: Lexington Books, 2004).

Anna Würth holds a Ph.D. in Islamic studies from the Free University of Berlin. She taught at the University of Richmond (Virginia) and at the Free University of Berlin. She is the author of *Aš-Šarī'a fī Bāāb al-Yaman: Recht, Richter und Rechtspraxis an der familienrechtlichen Kammer des Gerichts Süd-Sanaa, (Republik Jemen), 1983–1995* [Judges, the Law, and the Application of Law in the Personal Status Division of the South-Sanaa Court, 1985–1993] (Berlin: Duncker & Humblot, 2000), for which she did fieldwork in Yemen. Her research focuses on contemporary applications of Islamic law in Yemen and Egypt. Currently Würth is a researcher at the German Institute of Human Rights in Berlin, covering human rights in development cooperation. Recent publications include, together with Frauke Seidensticker, *Indices, Benchmarks, and Indicators: Planning and Evaluating Human Rights Dialogues* (Berlin: Deutsches Institut für Menschenrechte, 2005); and the forthcoming "Investigating and Prosecuting Police Abuse in Egypt," in the journal *Égypte/Monde Arabe* of the Centre d'Etudes et de Documentation Economique, Juridique et Sociale in Cairo.
