LAURENT BONELLI is a lecturer in politics at the University of Paris X-Nanterre. ELIZABETH HEGER BOYLE is an associate professor of sociology and law at the University of Minnesota. She studies human rights, immigration, and international law. Professor Boyle is currently working on a project, funded by the National Science Foundation, that considers how Muslim immigrants deal with perceived contradictions between Islamic and American law. Professor Boyle is the author of *Female Genital Cutting: Cultural Conflict in the Global Community* (Baltimore: Johns Hopkins, 2002). Her articles have appeared in *The Law & Society Review*, *International Sociology*, *Social Problems*, the *American Sociological Review*, and other journals.

ANNIE BUNTING is an associate professor in the Law & Society program at York University, teaching in the areas of social justice and human rights. Professor Bunting is a graduate of York, having studied law at Osgoode Hall Law School (1988). She received her LL.M. from the London School of Economics and Political Science (1991) and her SJD from the Faculty of Law, Uni-

versity of Toronto (1999). Her research concerns questions of women's rights, culture, and family practices including early marriage. Her article on early marriage, "Stages of Development: Marriage of girls and teens as an international human rights issue" was published in 14(1) *Social and Legal Studies* (2005).

BRENDA C. COUGHLIN is a PhD candidate in the Department of Sociology at Columbia University. Her dissertation traces the historical development of organized crime as a social and political category by analyzing the content of state-sponsored public hearings held between 1929 and 1986. She has published a review of research on street gangs in the United States (with Sudhir Alladi Venkatesh) and an analysis of political regret and public apologies (with Jeffrey K. Olick). Her next research project is a prison ethnography.

KATJA M. GUENTHER is an assistant professor of sociology at California State University, Fullerton. Her current research examines the development of local women's movements in eastern Germany since the collapse of state socialism there in 1989.

JOHN A. GUIDRY is associate director for research of the Division of Public Health at the New York Academy of Medicine. He is currently working with an applied participatory-research project involving community development partnerships around the United States. He has edited, along with Mayer Zald and Michael D. Kennedy, *Globalizations and Social Movements: Culture, Power, and the Transnational Public Sphere* (Ann Arbor: University of Michigan Press, 2000) and has authored several articles and chapters on citizenship, social movements, Brazilian politics, youth law in Brazil, and democratic theory.

RONALD KASSIMIR has been associate dean of the New School for Social Research and associate professor in its Department of Political Science since September 2005. From 1996 to 2005 he was program director for Africa at the Social Science Research Council. He also directed the International Dissertation Field Research Fellowship Program and coordinated a research network on Youth and Globalization. Kassimir has published on civil society and politics in Uganda, and most recently co-edited, with Thomas Callaghy and

Robert Latham, *Intervention and Transnationalism in Africa: Global-Local Networks of Power* (Cambridge: Cambridge, 2001); and, with Lonnie Sherrod, Constance Flanagan, and Amy Syvertsen, *Youth Activism: An International Encyclopedia* (Westport, CT: Greenwood Publishing, 2006).

SALLY ENGLE MERRY is a professor in anthropology and law and society at New York University. Her work explores the role of law in urban life in the United States, in the colonizing process, and in contemporary transnationalism. She is currently doing transnational research on human rights and gender. She was previously on the faculty of Wellesley College, where she was the Marion Butler McLean Professor in the history of ideas and professor of anthropology. Her books include a study of law and American colonialism in Hawai'i, *Colonizing Hawai'i: The Cultural Power of Law* (Princeton: Princeton Univ. Press, 2000), which received the 2001 J. Willard Hurst Prize from the Law and Society Association; and *Human Rights and Gender Violence: Translating International Law into Local Justice* (Chicago: University of Chicago Press, 2005). She is the author or editor of four other books and has recently published articles on women's human rights, violence against women, and the process of localizing human rights. She is a past president of the Law and Society Association and the Association for Political and Legal Anthropology.

JOHN MUNCIE is a professor of criminology and co-director of the International Centre for Comparative Criminological Research at the Open University, United Kingdom. He has published widely in the field of youth criminology including his sole-authored work *Youth and Crime* (London: Sage, 1st edition 1999; 2nd edition 2004) and the edited collections *Comparative Youth Justice* (London: Sage, 2006), *Youth Crime and Justice* (London: Sage, 2006), and *Youth Justice: Critical Readings*, (London: Sage, 2002). In addition he is the co-editor of the best-selling *The Sage Dictionary of Criminology* (London: Sage, 1st edition 2001; 2nd edition 2005) with Eugene McLaughlin and *Criminological Perspectives: Essential Readings* (London: Sage/Open University, 2003) with Gordon Hughes and Eugene McLaughlin.

ALEXANDRA K. MURPHY is a PhD candidate in the Sociology Department at Princeton University. Her work includes qualitative and ethnographic

work on the indoor sex trade in New York City, the transformation of public housing in Chicago, and the informal economy. She is co-author of the paper "Vice Careers: The Changing Contours of Sex Work in New York City," in the journal *Qualitative Sociology*, forthcoming. Alexandra is currently conducting ethnographic research on U.S. suburban ghettos.

TRINA SMITH is a PhD candidate in sociology at the University of Minnesota. She studies gender, human rights, and inequality. Her dissertation examines discourse and advocacy of international reproductive rights organizations to assess how they represent diverse women.

SUSAN J. TERRIO is an associate professor of French and cultural anthropology at Georgetown University, where she holds a joint appointment between the departments of French and Sociology and Anthropology. She is writing a monograph on the Paris juvenile court, centering in particular on recent threats to a rehabilitative ideal and the rise of a punitive trend that disproportionately affects minors who are foreign and of immigrant ancestry.

SUDHIR ALLADI VENKATESH, director of the Center for Urban Research and Policy, is professor of sociology and the director of research in the Institute for Research in African American Studies at Columbia University. Professor Venkatesh has done extensive ethnographic work examining issues of race, poverty, youth, and underground economies in Chicago and Harlem, and is the author of *American Project: The Rise and Fall of a Modern Ghetto* (Cambridge, MA: Harvard University Press, 2000).

ROB WHITE is a professor and head of the School of Sociology & Social Work at the University of Tasmania, Australia. He has research, scholarly, and practical interests in areas such as juvenile justice, crime prevention, youth studies, corrections, and green or environmental criminology. Among his publications are *No Space of Their Own* (Melbourne: Cambridge University Press, 1990), *Australian Youth Subcultures* (Hobart: Australian Clearinghouse for Youth Studies, 1999), *Youth & Society* (with Johanna Wyn, Oxford: Oxford University Press, 2004), and *Juvenile Justice* (with Chris Cunneen, Oxford:

Oxford University Press 2002), as well as a recent book *Controversies in Environmental Sociology* (Cambridge: Cambridge University Press, 2004).

ELANA ZILBERG is an assistant professor in Culture and Communication in the Communication Department at the University of California San Diego. She writes on transnational spaces produced at the nexus of migration, security, and urban policy between Los Angeles and San Salvador.
