Ien Ang is Professor of Cultural Studies and Australian Research Council Professorial Fellow at the Centre for Cultural Research, University of Western Sydney, in Australia. She has published numerous books and articles in media and cultural studies. Her latest book is *On Not Speaking Chinese: Living Between Asia and the West* (2001).

Tobias Hübnette (Korean name: Lee Sam-dol) is a researcher at the Multicultural Centre, Botkyrka, Sweden. His Ph.D. thesis in Korean Studies from 2005, "Comforting an Orphaned Nation," examined the Korean adoption issue and representations of adopted Koreans in Korean popular culture. He is researching issues concerning transnational adoption and transracial adoptees.

Evelyn Hu-DeHart is Professor of History and Ethnic Studies, and Director of the Center for the Study of Ethnicity and Race in America (CSREA) at Brown University. During the academic year 2005–06, she was Distinguished Freeman Visiting Professor in Asian/Asian American Studies at Wesleyan University, an initiative to bridge area studies (Asian studies) and ethnic studies (Asian American studies) around the themes of diaspora and transnationalism. Her most recent publication is *Voluntary Associations in the Chinese Diaspora* (coeditor with K. E. Kuah-Pearce, Hong Kong University Press, 2006).

Aisha Khan teaches anthropology at New York University. Her research interests include New World diasporas, Atlantic studies, postcolonial societies, and the construction of identities, particularly racial, ethnic, and religious. She has conducted ethnographic research among the Garifuna (Black Carib) in Honduras and among South Asians in the Republic of Trinidad and Tobago. Her books include *Callaloo Nation: Metaphors of Race and Religious Identity Among South Asians in Trinidad* (2004).

Richard S. Kim is an Assistant Professor in the Asian American Studies Program at the University of California, Davis. He has recently published articles in the *Journal of American Ethnic History*, *Amerasia Journal*, and *Seoul Journal of Korean Studies* and is currently completing a book on Korean diasporic nationalism.

Pei-Chia Lan is Associate Professor of Sociology at National Taiwan University. She has published articles in journals such as *Social Problems*, *Feminist Studies*, *Gender & Society*, *Identities*, *The Sociological Quarterly*, and *Journal of Family Issues*. Her book, *Global Cinderellas: Migrant Domesticity and Newly Rich Taiwanese Employers* was published by Duke University Press in 2006. She was a postdoctoral fellow at UC Berkeley in 2000–2001 and was a Fulbright scholar at New York University in 2006–2007.

Steven C. McKay is Assistant Professor of Sociology at the University of California, Santa Cruz. He is the author of *Satanic Mills or Silicon Islands? The Politics of High-Tech Production in the Philippines* (Cornell/ILR Press 2006) and coeditor of *Routing Diasporas: Labor, Citizenship and Empire* (forthcoming). He is currently completing an ethnographic study of Filipino seafarers onboard merchant ships, addressing work and racial formation in the global labor market.

David Palumbo-Liu is Professor of Comparative Literature at Stanford University. He is currently writing a book on the status of literary narrative under contemporary globalization, editing a collection of essays on rational choice theory and the humanities, and coediting a collection of essays assessing attempts at theorizing on the world scale. His articles have appeared in *boundary 2*, *diacritics*, *New Literary History*, and *New Centennial Review*. He is the author of *Asian/American: Historical Crossings of a Racial Frontier* (1999).

Rhacel Salazar Parreñas is Professor of Asian American Studies and the Graduate Group of Sociology at the University of California, Davis. She has written extensively on issues of women's migration, migrant domestic workers, and gender and intergenerational relations in transnational migrant families. She is currently working on a book project about Filipino migrant entertainers in the nightlife industry of Tokyo.

Sharmila Sen is the Editor for the Humanities at Harvard University Press. Prior to joining Harvard University Press, she was an assistant professor of English at Harvard where she specialized in postcolonial literature from Africa, the Caribbean, and South Asia. Her publications include essays on Caribbean fictions, francophone African novels, popular Bombay cinema, language politics in contemporary India, and border culture in South Asia.

Lok C. D. Siu is Associate Professor of Anthropology and Asian/Pacific/American studies in Social and Cultural Analysis at New York University. Her work focuses on diaspora, citizenship, transnationalism, migration, and Asians in the Americas. Her book, *Memories of a Future Home: Diasporic Citizenship of Chinese in Panama* (2005), won the 2005 Social Science book award from the Association for Asian American Studies. She is currently coediting a volume on gender and cultural citizenship and starting a new project that explores the cultural-social formation of Asian Latino restaurants in New York City.

Hung Cam Thai is Assistant Professor of Sociology and Asian American Studies at Pomona College in Claremont, California. He has conducted research in Vietnam and in the United States, with a special focus on Vietnamese transpacific marriages. His forthcoming book *For Better or for Worse: Marriage and Migration in the New Global Economy* will be published by Rutgers University Press.

Takeyuki (Gaku) Tsuda is Associate Professor of Anthropology at the School of Human Evolution and Social Change at Arizona State University (Tempe). Previously, he was a Collegiate Assistant Professor at the University of Chicago and then served as Associate Director of the Center for Comparative Immigration Studies at the University of California at San Diego. His primary academic interests include international migration, diasporas, ethnic minorities and identity, transnationalism and globalization, ethnic return migrants, the Japanese diaspora in the Americas, and contemporary Japanese society.
