

Jonathan D. Aronson is a professor at the University of Southern California and the director USC's School of International Relations. He also teaches at the Annenberg School of Communications. Professor Aronson's research focuses on international political economy, with special attention to trade negotiations, trade in services, comparative regulation, international strategic alliances, and especially international telecommunications. He also researches the impact of the globalization of telecommunications networks on international financial activities and the implications of these changes for regulation.

Naazneen Barma is a doctoral student in the Department of Political Science at the University of California, Berkeley. Her research interests lie in exploring how different types of political and institutional governance mechanisms affect political stability and economic development outcomes in post-conflict countries. Her dissertation is focused on reconstructing state capacity in post-conflict countries.
